## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Linwood Center**

3 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011  
4 to allow certain grants to be used for certain purposes; altering the deadline for  
5 a certain grantee to present evidence of a certain matching fund and to  
6 encumber funds for certain grants; and generally relating to amending the  
7 Maryland Consolidated Capital Bond Loan of 2011.

8 BY repealing and reenacting, with amendments,  
9 Chapter 396 of the Acts of the General Assembly of 2011  
10 Section 1(3) Item ZA02(A) and Item ZA03(C)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Chapter 396 of the Acts of 2011**

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That:

16 (3) ZA02 LOCAL SENATE INITIATIVES

17 (A) Linwood Center. Provide a grant equal to the lesser of (i)  
18 \$250,000 or (ii) the amount of the matching fund provided, to  
19 the Board of Directors of the Linwood Center, Inc. for the  
20 planning, [and] design, **CONSTRUCTION, AND CAPITAL**  
21 **EQUIPPING** of a new school building at the Linwood Center,  
22 located in Ellicott City. **NOTWITHSTANDING SECTION 1(5)**  
23 **OF THIS ACT, THE GRANTEE HAS UNTIL JUNE 1, 2014, TO**  
24 **PRESENT EVIDENCE THAT A MATCHING FUND WILL BE**
