1 AN ACT concerning

2 **Creation of a State Debt – Prince George’s County – Arthur & Mary E.**

5 to alter the grantee and the purpose of a certain grant; altering the matching
6 fund deadline and requirements for the grant; providing that the grant may not
7 terminate before a certain date; and generally relating to amending the

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:
