5 to alter the location of a certain grant; and generally relating to amending the
6 Maryland Consolidated Capital Bond Loan of 2012.

9 Section 1(3) Item ZA02(AY) and Item ZA03(AM)

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That the Laws of Maryland read as follows:

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 (AY) Quebec Terrace Lighting. Provide a grant equal to the lesser
17 of (i) \$58,000 or (ii) the amount of the matching fund provided,
18 to the Board of Trustees of ArtPreneurs, Inc. for the planning,
19 design, and construction of the Quebec Terrace lighting,
20 located in [Wheaton] **MONTGOMERY COUNTY**.
21 Notwithstanding Section 1(5) of this Act, the matching fund
22 may consist of in kind contributions (Montgomery County) 58,000

5 located in [Wheaton] **MONTGOMERY COUNTY**.
6 Notwithstanding Section 1(5) of this Act, the matching fund
7 may consist of in kind contributions (Montgomery County) 62,000

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 June 1, 2013.
