A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2003 – Baltimore City – Carroll**
3 **Mansion Museum**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2003
5 to extend the deadline for certain loan proceeds to be expended or encumbered;
6 and generally relating to amending the Maryland Consolidated Capital Bond
7 Loan of 2003.

8 BY repealing and reenacting, with amendments,
9 Chapter 204 of the Acts of the General Assembly of 2003, as amended by
10 Chapter 432 of the Acts of the General Assembly of 2004, Chapter 508 of
11 the Acts of the General Assembly of 2006, and Chapter 396 of the Acts of
12 the General Assembly of 2011
13 Section 13(3)(i) Item (H)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Chapter 204 of the Acts of 2003, as amended by Chapter 432 of the Acts of**
17 **2004, Chapter 508 of the Acts of 2006, and Chapter 396 of the Acts of 2011**

18 SECTION 13. AND BE IT FURTHER ENACTED, That:

19 (3) (i) \$15,200,000 for the following projects initially approved by the
20 Senate:

21 (H) Carroll Mansion Museum. Provide a grant equal to the lesser
22 of (i) \$75,000 or (ii) the amount of the matching fund provided,
23 to the Board of Directors of the Carroll Museums, Inc. for the
24 acquisition of heating, ventilating, and air conditioning
25 equipment, and for the repair and renovation of the Carroll

1 Mansion Museum, located in Baltimore City, subject to a
 2 requirement that the grantee grant and convey an historic
 3 easement to the Maryland Historical Trust. Notwithstanding
 4 Section 13(5) of this Act, the matching fund may consist of in
 5 kind contributions and the grantee must present evidence
 6 that a matching fund will be provided by June 1, 2008.
 7 Notwithstanding any other provision of law, the proceeds of
 8 the loan must be encumbered by the Board of Public Works or
 9 expended for the purposes provided in this Act no later than
 10 December 1, [2012] **2014** (Baltimore City) 75,000

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 12 June 1, 2013.
