Provide a grant equal to the lesser of (i) \$75,000 or (ii) the amount of the matching fund provided, to the Board of Directors of the Carroll Museums, Inc. for the acquisition of heating, ventilating, and air conditioning equipment, and for the repair and renovation of the Carroll

2	requirement that the grantee grant and convey an historic	
3	easement to the Maryland Historical Trust. Notwithstanding	
4	Section 13(5) of this Act, the matching fund may consist of in	
5	kind contributions and the grantee must present evidence	
6	that a matching fund will be provided by June 1, 2008.	
7	Notwithstanding any other provision of law, the proceeds of	
8	the loan must be encumbered by the Board of Public Works or	
9	expended for the purposes provided in this Act no later than	
10	December 1, [2012] 2014 (Baltimore City)	75,000

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 $\,$ June 1, 2013.
