#### A BILL ENTITLED

#### 1 AN ACT concerning

#### 2 Dorchester County – Turkey Hunting on Public Land – Sundays

# FOR the purpose of authorizing a person to hunt turkey on public land on certain Sundays in Dorchester County; making this Act an emergency measure; and generally relating to turkey hunting on Sundays.

## 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That the Laws of Maryland read as follows:

## Article – Natural Resources

14 10-410.

15 (a) (1) Except as provided in paragraphs (2), (3), (4), and (6) of this 16 subsection, a person may not hunt any game bird or mammal on Sundays.

17 (2) The following persons may hunt the specified game birds and 18 mammals on Sundays:

19 (i) A person using State certified raptors to hunt game birds or20 mammals during open season;

(ii) An unarmed person participating in an organized fox chase
to chase foxes;

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from
