## Harford County Liquor Control Board – Reserve Account

- 3 FOR the purpose of establishing a Reserve Account of the Harford County Liquor 4 Control Board as a special, nonlapsing account; specifying the purpose of the  $\mathbf{5}$ Reserve Account; requiring a designee of the Board to administer the Reserve 6 Account; requiring the Board to hold the Reserve Account separately and 7 account for the Reserve Account; specifying the contents of the Reserve Account; 8 specifying a certain maximum amount that is payable annually into the 9 Reserve Account; specifying the circumstances under which expenditures from the Reserve Account may occur; stating a certain maximum amount that the 10 Reserve Account may hold at any time; requiring that fines imposed or 11 12recognizances forfeited for certain violations be payable to the Board; defining 13 certain terms; making certain stylistic changes; clarifying language; and generally relating to the Reserve Account of the Harford County Liquor Control 1415Board.

INTEREST OR OTHER INCOME EARNED FROM THE 6 INVESTMENT OF ANY PORTION OF THE RESERVE ACCOUNT; AND 75. ANY OTHER MONEY FROM ANY OTHER SOURCE 8 ACCEPTED FOR THE BENEFIT OF THE RESERVE ACCOUNT. 9 (VII) EACH YEAR, THE AMOUNT PAYABLE INTO THE RESERVE ACCOUNT MAY NOT BE MORE THAN 20% OF THE AGGREGATE NET PROCEEDS 10 **RECEIVED BY THE BOARD.** 11 12(VIII) EXPENDITURES FROM THE RESERVE ACCOUNT MAY OCCUR IF THE BOARD DETERMINES THAT APPROPRIATIONS FOR THE CURRENT 1314YEAR EXCEED EXPECTED REVENUES. 15(IX) THE RESERVE ACCOUNT MAY NOT EXCEED \$100,000 AT 16 ANY TIME. 17The net proceeds of the funds derived from the sale of **[**(3)**] (5)** licenses within the corporate limits of the municipalities of Aberdeen, Bel Air and 18 19 Havre de Grace, after the deduction of a proportionate part of the expenses incident to 20the proper administration and enforcement of this article, shall be paid by the Board 21to the treasurers of the respective towns, to be applied to the payment of the interest 22and the redemption of the principal of any bonded indebtedness. 23**[**(4)**] (6)** All expenses incident to the proper administration and 24enforcement of this article, including the salaries of the members of the Board, and the 25proper proportion of the salaries of any employees of the Board, whose duties include 26the handling of licenses, including the salaries of officers, inspectors, etc., shall be 27deducted proportionately from the shares of the license fees payable as set forth in this 28subsection, to the general funds of the county and the governing bodies of the three 29municipalities. 30 **[**(5)**] (7)** (i) Prior to the beginning of each fiscal year, the Board 31shall submit an annual budget to the County Council and County Executive for 32review. 33 Except as provided under § 15-205(i)(3) of this article, the (ii)

34 budget is not subject to approval by the County Council or County Executive.
