#### 1 AN ACT concerning

## 2 Public Schools – Emergency Management Plans – Evaluations

- 3 FOR the purpose of requiring each county board of education to evaluate the 4 effectiveness of the emergency management plan in each public school under  $\mathbf{5}$ the jurisdiction of the county board on or before a certain date; requiring each 6 county board of education to report to the State Department of Education on a 7 certain evaluation on or before a certain date; requiring the Department to 8 make a certain report to the General Assembly on or before a certain date; 9 providing for the termination of this Act; and generally relating to the 10 evaluation of emergency management plans in the public schools in the State.

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows:

It shall remain effective for a period of 1 year and, at the end of May 31, 2014, with no further action required by the General Assembly, this Act shall be 2627abrogated and of no further force and effect.
