3 FOR the purpose of requiring that inspections of certain forensic laboratories be 4 conducted with a certain frequency; requiring the Secretary of Health and $\mathbf{5}$ Mental Hygiene to authorize a certain nonprofit accreditation body to inspect 6 certain forensic laboratories in the State; requiring certain forensic laboratories 7 to obtain accreditation from a certain nonprofit accreditation body before 8 applying for a certain license; requiring the Secretary to approve a certain 9 nonprofit accreditation body to accredit forensic laboratories in the State; requiring a licensee to submit evidence to the Secretary of current accreditation 10 from a certain nonprofit accreditation body in order to renew its license; 11 12specifying certain matters relating to the implementation of certain provisions 13 of this Act about which the Forensic Laboratory Advisory Committee must advise the Secretary; defining a certain term; and generally relating to the 14regulation of forensic laboratories in the State. 15
