16 17	(a) (1) Except as otherwise provided in subsection (b) of this section or in other law, the effective date of a regulation is:
18 19 20	(I) JANUARY 1 IF THE NOTICE OF ADOPTION IS PUBLISHED IN THE REGISTER DURING THE PERIOD FROM SEPTEMBER 1 THROUGH NOVEMBER 30, BOTH INCLUSIVE;
21 22 23	(II) APRIL 1 IF THE NOTICE OF ADOPTION IS PUBLISHED IN THE REGISTER DURING THE PERIOD FROM DECEMBER 1 THROUGH FEBRUARY 29, BOTH INCLUSIVE;



1 2 3	(III) JULY 1 IF THE NOTICE OF ADOPTION IS PUBLISHED IN THE REGISTER DURING THE PERIOD FROM MARCH 1 THROUGH MAY 31, BOTH INCLUSIVE;
