CHAPTER _____

1 AN ACT concerning

2 **Health Occupations – Funeral Establishments – Preparation and**
3 **Holding Rooms**

4 FOR the purpose of establishing that a funeral establishment that uses a central
5 preparation room at another funeral establishment is not required to have its
6 own preparation room or holding room; and generally relating to funeral
7 establishments.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Health Occupations**

16 7–310.

17 (a) (1) A funeral establishment shall be licensed by the Board before the
18 establishment may be used for the preparation of the remains, viewing, and
19 conducting of services.

1 (2) The licensee may be restricted to operations as determined by the
2 Board.

3 (b) (1) To apply for a funeral establishment license, an applicant shall:

4 (i) Submit an application to the Board on the form that the
5 Board requires; and

6 (ii) Pay to the Board:

7 1. An application fee set by the Board; and

8 2. The fee established under § 7-4A-05(a) of this title.

9 (2) An application for a funeral establishment license shall be signed
10 by a licensed individual who is not an apprentice but is the owner or co-owner of the
11 establishment to be licensed.

12 (c) The Board shall issue a funeral establishment license to a funeral
13 establishment that:

14 (1) Has complied with all applicable State and local laws;

15 (2) Will be owned and operated in accordance with this title by at least
16 one licensed mortician or one licensed funeral director, or a holder of a surviving
17 spouse or corporation license; and

18 (3) Will be held responsible for any and all activities performed on the
19 premises.

20 (d) Signs and advertisements of a funeral establishment shall display the
21 name that appears on the establishment license.

22 **(E) A FUNERAL ESTABLISHMENT THAT USES A CENTRAL PREPARATION**
23 **ROOM AT ANOTHER FUNERAL ESTABLISHMENT IS NOT REQUIRED TO HAVE ITS**
24 **OWN PREPARATION ROOM OR HOLDING ROOM.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2013.
