- 3 FOR the purpose of altering a certain fee collected by the State Department of Assessments and Taxation for the filing of certain documents by certain 4 $\mathbf{5}$ corporations and business entities; requiring certain corporations to compute 6 Maryland taxable income using a certain method; requiring, subject to 7 regulations adopted by the Comptroller, certain groups of corporations to file a 8 combined income tax return reflecting the aggregate income tax liability of all 9 the members of the group; requiring the Comptroller to adopt certain 10 regulations; requiring certain regulations to be consistent with certain 11 regulations adopted by the Multistate Tax Commission; defining certain terms; providing for the application of this Act; and generally relating to fees collected 12by the State Department of Assessments and Taxation and the Maryland 1314corporate income tax.
