## Higher Education – Charles W. Riley Firefighter and Ambulance and Rescue Squad Member Scholarship

FOR the purpose of establishing the Charles W. Riley Firefighter and Ambulance and Rescue Squad Member Scholarship; establishing certain eligibility requirements for the scholarship; authorizing the use of the scholarship for certain educational expenses; authorizing the annual amount of the scholarship awarded to be up to a certain percentage of the equivalent tuition and certain fees of a certain institution of higher education; requiring the scholarship recipient to maintain a certain grade point average; providing for the duration of the scholarship; requiring scholarship applicants and recipients to file for certain federal and State financial aid by a certain date; authorizing legislative scholarship funds to be used for certain purposes; providing that funds for the scholarship are as provided in a certain annual budget by the Governor; establishing a certain fund; requiring the Maryland Higher Education Commission to administer a certain fund; providing that the fund is a certain special, nonlapsing fund that is not subject to a certain section of the State Finance and Procurement Article; requiring the State Treasurer to hold the fund separately and requiring the Comptroller to account for the fund; directing

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 41MARYLAND, That the Laws of Maryland read as follows: 42

(2008 Replacement Volume and 2012 Supplement)

#### Article - Education 1 2 18–101. 3 In this title the following words have the meanings indicated. (a) "Commission" means the Maryland Higher Education Commission. 4 (b) "Office" means the Office of Student Financial Assistance. 5 (c) "Secretary" means the Secretary of Higher Education. 6 (d) 7 18–103. 8 In this title, "in-State institution of higher education" means a 9 degree-granting institution whose primary campus is located in Maryland and whose 10 authority to grant degrees is conferred by Maryland. 11 A scholarship, grant, loan, or other student financial assistance awarded by the Office may be used only at an in-State institution of higher education that 12 possesses a certificate of approval from the Commission. 13 18-603.1. 14 15 (A) **(1)** IN THIS SECTION THE FOLLOWING WORDS HAVE THE 16 MEANINGS INDICATED. 17 **(2)** "ELIGIBLE INSTITUTION" MEANS A PUBLIC OR PRIVATE 18 NONPROFIT INSTITUTION OF HIGHER EDUCATION IN THE STATE THAT 19 POSSESSES A CERTIFICATE OF APPROVAL FROM THE COMMISSION.

- 23 <u>CONCENTRATION IN FIRE SERVICE TECHNOLOGY OR FIRE SERVICE</u>
- 24 MANAGEMENT; AND
- 25 (II) FOR A VOLUNTEER FIREFIGHTER OR AMBULANCE OR
- 26 RESCUE SQUAD MEMBER, MAY BE UP TO 100% OF THE EQUIVALENT ANNUAL
- 27 TUITION AND MANDATORY FEES OF A RESIDENT UNDERGRADUATE STUDENT AT
- 28 THE 4-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION WITHIN THE
- 29 UNIVERSITY SYSTEM OF MARYLAND, OTHER THAN THE UNIVERSITY OF
- 30 MARYLAND UNIVERSITY COLLEGE AND UNIVERSITY OF MARYLAND,
- 31 BALTIMORE, WITH THE HIGHEST ANNUAL EXPENSES FOR A FULL-TIME
- 32 RESIDENT UNDERGRADUATE FOR COURSES CREDITED TOWARD A DEGREE.
- 33 (E) A SCHOLARSHIP RECIPIENT SHALL MAINTAIN A GRADE POINT
- 34 AVERAGE OF AT LEAST 2.5 ON A 4.0 SCALE.

- 1 (F) EACH RECIPIENT OF A SCHOLARSHIP UNDER THIS SECTION MAY 2 HOLD THE AWARD FOR 5 YEARS OF FULL-TIME STUDY OR 8 YEARS OF 3 PART-TIME STUDY.
- 4 (G) A SCHOLARSHIP APPLICANT OR RECIPIENT SHALL FILE FOR 5 FEDERAL AND STATE FINANCIAL AID BY MARCH 1 OF EACH YEAR.
- 6 (H) A SENATOR OR DELEGATE MAY AUTHORIZE THE OFFICE TO AWARD
  7 ALL OR A PORTION OF THE FUNDS AUTHORIZED UNDER SUBTITLES 4 AND 5 OF
  8 THIS TITLE TO ELIGIBLE RECIPIENTS OF SCHOLARSHIPS AWARDED UNDER THIS

- 10 (I) (1) FUNDS FOR THE CHARLES W. RILEY FIREFIGHTER AND 11 AMBULANCE AND RESCUE SQUAD MEMBER SCHOLARSHIP SHALL BE AS 12 PROVIDED IN THE ANNUAL BUDGET OF THE COMMISSION BY THE GOVERNOR.
- 13 (2) THERE IS A CHARLES W. RILEY FIREFIGHTER AND 14 AMBULANCE AND RESCUE SQUAD MEMBER SCHOLARSHIP FUND IN THE 15 COMMISSION.
- 16 (3) THE COMMISSION SHALL ADMINISTER THE FUND.
- 17 (4) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
- 19 (5) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY 20 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.
- 21 **(6)** THE COMMISSION:
- 22 (I) MAY ACCEPT ANY GIFT OR GRANT FROM ANY PERSON 23 OR CORPORATION FOR THE FUND;
- 24 (II) SHALL USE ANY GIFT OR GRANT THAT IT RECEIVES FOR 25 A SCHOLARSHIP FROM THE FUND; AND
- 26 (III) SHALL DEPOSIT ANY GIFT OR GRANT THAT IT RECEIVES FOR THE FUND WITH THE STATE TREASURER.
- 28 (7) (I) AT THE END OF THE FISCAL YEAR, THE COMMISSION 29 SHALL PREPARE AN ANNUAL REPORT ON THE FUND THAT INCLUDES AN 30 ACCOUNTING OF ALL FINANCIAL RECEIPTS AND EXPENDITURES TO AND FROM
- 31 THE FUND.

- 1 (II) THE COMMISSION SHALL SUBMIT A COPY OF THE 2 REPORT TO THE GENERAL ASSEMBLY IN ACCORDANCE WITH § 2–1246 OF THE 3 STATE GOVERNMENT ARTICLE.
- 4 (J) A RECIPIENT OF A SCHOLARSHIP SHALL WORK FOR AT LEAST 1
  5 YEAR AS A VOLUNTEER OR CAREER FIREFIGHTER OR AMBULANCE OR RESCUE
  6 SQUAD MEMBER IN AN ORGANIZED FIRE DEPARTMENT OR AMBULANCE OR
  7 RESCUE SQUAD IN THE STATE AFTER COMPLETION OF AN ELIGIBLE PROGRAM
  8 IN AN ELIGIBLE INSTITUTION.
- 9 (K) A SCHOLARSHIP RECIPIENT SHALL REPAY THE COMMISSION THE
  10 FUNDS RECEIVED UNDER THIS SECTION IF THE RECIPIENT DOES NOT PERFORM
  11 THE SERVICE OBLIGATION REQUIRED UNDER SUBSECTION (J) OF THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

- 16 (f) (1) This subsection does not apply to a traffic case under § 21–202.1, § 21–809, or § 21–810 of the Transportation Article or to a parking or impounding case.

- 20 (3) (i) The Comptroller annually shall credit the surcharges 21 collected under this subsection as provided in this paragraph.

- 27 (iii) After the distribution under subparagraph (ii) of this 28 paragraph, \$200,000 shall be distributed to the Maryland State Firemen's Association.
- (iv) After the distribution under subparagraphs (ii) and (iii) of this paragraph and until a total of \$20,000,000 has been distributed to the Volunteer Company Assistance Fund since the establishment of the surcharge under this subsection, the remainder shall be credited to the Volunteer Company Assistance Fund to be used in accordance with the provisions of Title 8, Subtitle 2 of the Public Safety Article.

5 6 7 8 9	(vi) On or before September 1 of each year until \$20,000,000 has been distributed to the Volunteer Company Assistance Fund, the State Court Administrator shall submit a report to the Senate Budget and Taxation Committee and the House Appropriations Committee, in accordance with § 2–1246 of the State Government Article, on the amount of revenue distributed to the Volunteer Company Assistance Fund under this paragraph.

15 16 17 18 19 20 21 22	(b) As provided in the State budget, any career or volunteer firefighter or ambulance or rescue squad member who is a resident of Maryland shall receive partial or full and complete reimbursement by the Office for tuition costs not to exceed the resident tuition rates at the 4–year public institution of higher education within the University System of Maryland, other than the University of Maryland University College and University of Maryland, Baltimore, with the highest annual expenses for a full–time resident undergraduate, for courses credited toward a degree in fire service technology or emergency medical technology.
23 24 25	(c) (1) The tuition reimbursement application shall be filed with the Office no later than July 1 immediately following the academic year for which tuition reimbursement is sought.
26 27	(2) Payment shall be made 1 year after successful completion of each academic year.

SECTION 4. AND BE IT FURTHER ENACTED, That on October 2, 2015, any funds remaining in the Charles W. Riley Fire and Emergency Medical Services Tuition Reimbursement Program shall be transferred to the Charles W. Riley Firefighter and
