21 22 23	(III) COLLECT, IN ADVANCE, A \$20 FEE FOR DOCKETING THE APPEARANCE OF COUNSEL WHEN BRINGING OR DEFENDING A CASE IN THE COURT OF SPECIAL APPEALS OR COURT OF APPEALS.
24 25	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2013.
