BY repealing and reenacting, with amendments, Article – Real Property Section 8B–101, 8B–102(a), and 8B–202(b) and (c) Annotated Code of Maryland (2010 Replacement Volume and 2012 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Real Property 8B-101.
