- 17 order the respondent to refrain from abusing or threatening to (1)18 abuse any person eligible for relief;
- order the respondent to refrain from contacting, attempting to 19(2)contact, or harassing any person eligible for relief; 20
- 21(3)order the respondent to refrain from entering the residence of any 22person eligible for relief;

where the person eligible for relief and the respondent are residing 1 (4) $\mathbf{2}$ together at the time of the abuse, order the respondent to vacate the home 3 immediately and award temporary use and possession of the home to the person 4 eligible for relief or, in the case of alleged abuse of a child or alleged abuse of a $\mathbf{5}$ vulnerable adult, award temporary use and possession of the home to an adult living 6 in the home, provided that the court may not grant an order to vacate and award 7temporary use and possession of the home to a nonspouse person eligible for relief 8 unless the name of the person eligible for relief appears on the lease or deed to the 9 home or the person eligible for relief has shared the home with the respondent for a 10 period of at least 90 days within 1 year before the filing of the petition;

20 [(7)] (8) award temporary custody of a minor child of the respondent 21 and a person eligible for relief;

[(8)] (9) establish temporary visitation with a minor child of the respondent and a person eligible for relief on a basis which gives primary consideration to the welfare of the minor child and the safety of any other person eligible for relief. If the court finds that the safety of a person eligible for relief will be jeopardized by unsupervised or unrestricted visitation, the court shall condition or restrict visitation as to time, place, duration, or supervision, or deny visitation entirely, as needed to guard the safety of any person eligible for relief;

[(9)] (10) award emergency family maintenance as necessary to support any person eligible for relief to whom the respondent has a duty of support under this article, including an immediate and continuing withholding order on all earnings of the respondent in the amount of the ordered emergency family maintenance in accordance with the procedures specified in Title 10, Subtitle 1, Part III of this article;

[(10)] (11) award temporary use and possession of a vehicle jointly owned by the respondent and a person eligible for relief to the person eligible for relief if necessary for the employment of the person eligible for relief or for the care of a minor child of the respondent or a person eligible for relief;

1 [(11)] (12) direct the respondent or any or all of the persons eligible for 2 relief to participate in professionally supervised counseling or a domestic violence 3 program;

4 [(12)] (13) order the respondent to pay filing fees and costs of a 5 proceeding under this subtitle; or

6 [(13)] (14) award temporary possession of any pet of the person eligible 7 for relief or the respondent.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 June 1, 2013.
