Business Occupations - Oil and Gas Land Professionals - Registration

3 FOR the purpose of prohibiting a person from operating as an oil or gas land 4 professional in the State unless the person registers with and obtains a 5 registration certificate from the Department of Labor, Licensing, and 6 Regulation; requiring a person to register as a land professional by submitting a 7 certain form and a certain fee to the Department; requiring the Department to 8 assign a registration number and issue a registration certificate to a certain 9 person; providing for the expiration and renewal of a certain registration; requiring a land professional to provide certain proof to a property owner before 10 11 obtaining any mineral rights in oil or gas from the property owner; requiring 12 the Department to adopt certain regulations to implement this Act; requiring 13 the Department to develop a means for providing public access to certain 14 information; establishing certain penalties; defining certain terms; and 15 generally relating to the registration of oil and gas land professionals in the 16 State.
