1	and Procurement Article, that are provided to Frederick County under this Act shall
2	apply only for a procurement for the construction of one elementary school in
3	Frederick County, the procurement for which begins on or after the effective date of
1	this Act.

SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2013. It shall remain effective for a period of 2 years and, at the end of June 30, 2015, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
