- FOR the purpose of designating a motor vehicle insurer or the Maryland Automobile 3 4 Insurance Fund as the agent for a certain driver or the estate of the driver with 5 regard to a subpoena, summons, or other process issued in a certain action 6 involving a certain motor vehicle under certain circumstances; authorizing 7 process to be served on a motor vehicle insurer or the Maryland Automobile 8 Insurance Fund under certain circumstances; defining a certain term; providing 9 for the application of this Act; and generally relating to service of process under certain circumstances. 10

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 20 (A) IN THIS SECTION, "UNINSURED MOTOR VEHICLE" MEANS A MOTOR 21 VEHICLE FOR WHICH:
- 22 (1) THE SECURITY REQUIRED UNDER § 17–103 OF THE 23 TRANSPORTATION ARTICLE IS NOT IN FORCE; OR

1	(2) THE SECURITY REQUIRED UNDER § 17–103 OF THE
2	TRANSPORTATION ARTICLE IS IN FORCE BUT A RECEIVER OR CONSERVATOR
3	HAS BEEN APPOINTED BY A COURT FOR THE INSURER THAT ISSUED THE
1	SECURITY

- 5 (B) (1) THIS SECTION APPLIES TO AN ACTION THAT IS RELATED TO 6 AN ACCIDENT OR COLLISION INVOLVING A MOTOR VEHICLE DRIVEN BY A 7 PERSON WHO:
  - (I) IS NAMED AS A PARTY TO THE ACTION; AND
- 9 (II) HAS DIED.
- 10 (2) PARAGRAPH (1) OF THIS SUBSECTION APPLIES WHETHER OR
  11 NOT THE ACTION WAS COMMENCED DURING THE LIFETIME OF THE PERSON
  12 DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION.
- 13 (C) By driving a motor vehicle in this State, a person, subject
  14 to subsections (d) and (e) of this section, irrevocably appoints the
  15 person's motor vehicle insurer or the Maryland Automobile
  16 Insurance Fund as agent to receive a subpoena, a summons, or other
  17 process directed to the person.
- 18 (D) IN AN ACTION AGAINST A PERSON WHO WAS THE DRIVER OF A
  19 MOTOR VEHICLE INSURED UNDER AN INSURANCE POLICY OR SELF-INSURANCE
  20 PLAN AT THE TIME THE ALLEGED LIABILITY THAT IS THE SUBJECT OF THE
  21 ACTION WAS INCURRED OR IN AN ACTION AGAINST THE ESTATE OF THE PERSON,
  22 PROCESS MAY BE SERVED ON THE MOTOR VEHICLE INSURER OF THE PERSON.
- (E) IN AN ACTION AGAINST A PERSON WHO WAS THE DRIVER OF AN UNINSURED MOTOR VEHICLE AT THE TIME THE ALLEGED LIABILITY THAT IS THE SUBJECT OF THE ACTION WAS INCURRED OR IN AN ACTION AGAINST THE ESTATE OF THE PERSON, PROCESS MAY BE SERVED ON THE MARYLAND AUTOMOBILE INSURANCE FUND.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any case filed before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2013.
