A BILL ENTITLED

1 AN ACT concerning

2 Health Occupations – Massage Therapy – Authority to Practice

3 FOR the purpose of requiring an individual to be registered by the State Board of 4 Chiropractic and Massage Therapy Examiners before the individual may $\mathbf{5}$ practice massage therapy in a certain setting; altering the number of hours and 6 content of certain education an applicant for a license to practice massage 7 therapy must complete to qualify for a license; repealing a certain provision of 8 law that prohibits an individual who is registered to practice non-therapeutic 9 massage from practicing in certain offices, hospitals, or facilities; altering certain definitions; repealing a certain definition; making conforming changes; 10 and generally relating to the practice of massage therapy in the State. 11
