A BILL ENTITLED

1 AN ACT concerning

Task Force to Evaluate the Impact of Maryland's Proposal to Maintain the Medicare Waiver

4 FOR the purpose of establishing the Task Force to Evaluate the Impact of Maryland's $\mathbf{5}$ Proposal to Maintain the Medicare Waiver; providing for the composition, chair, 6 and staffing of the Task Force; prohibiting a member of the Task Force from $\mathbf{7}$ receiving certain compensation, but authorizing the reimbursement of certain 8 expenses; requiring the Task Force to study certain matters related to a certain 9 waiver application; requiring the Task Force to report its findings to the 10 Governor and certain standing committees of the General Assembly on or before 11 a certain date; providing for the termination of this Act; and generally relating 12to the Task Force to Evaluate the Impact of Maryland's Proposal to Maintain 13 the Medicare Waiver.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That:

16 (a) There is a Task Force to Evaluate the Impact of Maryland's Proposal to17 Maintain the Medicare Waiver.

18 (b) The Task Force consists of the following members:

19 (1) two members of the Senate of Maryland, one of whom shall be a 20 member of the minority party, appointed by the President of the Senate;

(2) two members of the House of Delegates, one of whom shall be a
member of the minority party, appointed by the Speaker of the House;
