Senate Bill 255 (Senator Montgomery, et al.)

Education, Health, and Environmental Affairs

State Government - Commemorative Days - Rare Disease Day

This bill requires the Governor to annually proclaim the last day of February as Rare Disease Day.

Fiscal Summary

State Effect: Commemorating Rare Disease Day does not affect State finances.

Local Effect: None.

Small Business Effect: None.

Analysis

Current Law: Nine official commemorative days and three months are recognized in State law as shown in **Exhibit 1**. The Governor also must issue a proclamation each year encouraging citizens and other individuals to observe a moment of silence at 3 p.m. on Memorial Day to unite in remembrance and commemorate the heroic acts and efforts of Marylanders who have served and died in the U.S. Armed Forces.

Background: A "rare disease or condition" is defined by the federal Orphan Drug Act as a disease or condition which affects less than 200,000 in the United States. According to the National Organization for Rare Disorders (NORD), there are nearly 7,000 such diseases affecting nearly 30 million Americans or about 1 in 10 people.

As noted in the bill's preamble, people suffering from rare diseases typically experience difficulties in obtaining timely and accurate diagnoses and have limited treatment options

and difficulties in finding health care professionals or treatment centers with knowledge and experience regarding the disease. Even after obtaining a diagnosis, treatments for rare diseases are often expensive and can bring financial hardships to patients and their families.

February 28, 2013, will mark the sixth international Rare Disease Day coordinated by Rare Diseases Europe. Since Rare Disease Day was first launched in 2008, more than 1,000 events have taken place throughout the world. NORD is the U.S. sponsor of the day, and more than 800 patient organizations, government agencies, educational institutions, clinical centers, and companies have signed on as Rare Disease Day Partners in the United States.
