AMENDMENTS TO HOUSE BILL 14, AS AMENDED
(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, in the sponsor line, strike “Simmons” and substitute “Clippinger”; and in line 7, after “coaches;” insert “prohibiting a certain person from engaging in a sexual act, sexual conduct, or vaginal intercourse with a minor who the person is directly supervising in a county department of recreation program;”.

In the House Judiciary Committee Amendments (HB0014/922319/1), in line 1 of Amendment No. 1, after “K. Kelly,” insert “Simmons,”; and in line 4, before the first “certain” insert “certain employees of a county department of recreation,”.

AMENDMENT NO. 2

On page 2 of the bill, in line 28, after “means” insert “:

(I);

and in lines 29 and 30, strike “(i)” and “(ii)”, respectively, and substitute “**1.**” and “**2.**”, respectively.

In the House Judiciary Committee Amendments, in lines 2 and 4 of Amendment No. 2, strike “**1.**” and “**2.**”, respectively, and substitute “**A.**” and “**B.**”, respectively.

On page 3 of the bill, in line 1, strike “(iii)” and substitute “**3.**”; in line 2, after “school” insert “;**OR**

(II) **A PERSON WHO:**

1. **IS AT LEAST 21 YEARS OLD;**

2. IS EMPLOYED BY OR UNDER CONTRACT WITH:

A. A COUNTY DEPARTMENT OF RECREATION; OR

B. A CONTRACTOR OF A COUNTY DEPARTMENT OF RECREATION; AND

3. BECAUSE OF THE PERSON'S POSITION OR OCCUPATION, EXERCISES SUPERVISION OVER A MINOR WHO PARTICIPATES IN A COUNTY DEPARTMENT OF RECREATION PROGRAM”;

in line 13, after “(1)” insert “**(I)**”; in line 14, after “authority” insert “**, AS DEFINED IN SUBSECTION (A)(1)(I) OF THIS SECTION,**”; after line 16, insert:

“(II) EXCEPT AS PROVIDED IN § 3-307(A)(4) OF THIS SUBTITLE OR SUBSECTION (B)(2) OF THIS SECTION, A PERSON IN A POSITION OF AUTHORITY, AS DEFINED IN SUBSECTION (A)(1)(II) OF THIS SECTION, MAY NOT ENGAGE IN A SEXUAL ACT OR SEXUAL CONTACT WITH A MINOR WHO, AT THE TIME OF THE SEXUAL ACT OR SEXUAL CONTACT, THE PERSON IN A POSITION OF AUTHORITY IS DIRECTLY SUPERVISING IN A COUNTY DEPARTMENT OF RECREATION PROGRAM.”;

in line 17, after “(2)” insert “**(I)**”; in line 18, after “authority” insert “**, AS DEFINED IN SUBSECTION (A)(1)(I) OF THIS SECTION,**”; and after line 20, insert:

“(II) EXCEPT AS PROVIDED IN § 3-307(A)(5) OF THIS SUBTITLE OR SUBSECTION (B)(3) OF THIS SECTION, A PERSON IN A POSITION OF AUTHORITY, AS DEFINED IN SUBSECTION (A)(1)(II) OF THIS SECTION, MAY NOT ENGAGE IN VAGINAL INTERCOURSE WITH A MINOR WHO, AT THE TIME OF THE
