# <u>AMENDMENTS TO HOUSE BILL 1187</u> (First Reading File Bill)

#### AMENDMENT NO. 1

On page 1, strike beginning with "specifying" in line 3 down through "necessity;" in line 9 and substitute "<u>requiring a person to file a certain application for approval to</u> <u>construct a certain generating station at least a certain time before construction</u> <u>commences</u>;"; in line 10, after the first "a" insert "<u>certain</u>"; strike beginning with "based" in line 11 down through "deposit" in line 14; in lines 22 and 23, strike "and certificates of public convenience and necessity"; and strike in their entirety lines 24 through 28, inclusive.

#### AMENDMENT NO. 2

On pages 2 through 7, strike in their entirety the lines beginning with line 18 on page 2 through line 23 on page 7, inclusive.

#### AMENDMENT NO. 3

On page 7, in line 25, strike "(1)"; in the same line, strike "SUBSECTION" and substitute "<u>SECTION</u>"; in lines 27 and 30, strike "(I)" and "(II)", respectively, and substitute "(1)" and "(2)", respectively; in line 28, strike "AND NOT MORE THAN 10 MEGAWATTS"; and after line 32, insert:

# "(B) (1) <u>A PERSON SHALL FILE AN APPLICATION FOR APPROVAL TO</u> <u>CONSTRUCT A GENERATING STATION UNDER § 7-207.1 OF THIS SUBTITLE AT</u> <u>LEAST 6 MONTHS BEFORE CONSTRUCTION COMMENCES.</u>".

On page 8, strike beginning with "IF" in line 1 down through the first "THE" in line 3 and substitute "<u>THE</u>"; in line 3, strike "THE PERSON" and substitute "<u>A</u> PERSON WHO FILES AN APPLICATION FOR APPROVAL TO CONSTRUCT A

<u>GENERATING STATION</u>"; strike in their entirety lines 5 through 25, inclusive; in line 26, strike "(D)" and substitute "<u>(C)</u>"; in line 27, strike "SUBSECTIONS (A) AND" and substitute "<u>SUBSECTION</u>"; in line 28, strike "BEGINS A PROJECT WITHIN 3 YEARS" and substitute "<u>DEMONSTRATES TO THE COMMISSION THAT THE PERSON IS</u> <u>FULLY AUTHORIZED TO COMMENCE CONSTRUCTION WITHIN 18 MONTHS</u>"; strike beginning with "OR" in line 29 down through "NECESSITY" in line 30; in line 31, after "DEPOSIT" insert "<u>, LESS REASONABLE ADMINISTRATIVE COSTS</u>"; and in line 33, strike "BEGIN A PROJECT WITHIN 3 YEARS" and substitute "<u>COMMENCE</u> <u>CONSTRUCTION WITHIN 18 MONTHS</u>".

On page 9, strike beginning with "OR" in line 1 down through "NECESSITY" in line 2; in line 7, after "ARTICLE" insert "<u>, LESS REASONABLE ADMINISTRATIVE</u> <u>COSTS</u>"; in line 9, strike "BEGIN WITHIN 3 YEARS" and substitute "<u>COMMENCE</u> <u>CONSTRUCTION WITHIN 18 MONTHS</u>"; and strike beginning with "OR" in line 10 down through "NECESSITY" in line 11.
