## A BILL ENTITLED

AN ACT concerning

### **Task Force to Evaluate the Impact of Maryland's Proposal to Maintain the Medicare Waiver**

FOR the purpose of establishing the Task Force to Evaluate the Impact of Maryland's Proposal to Maintain the Medicare Waiver; providing for the composition, chair, and staffing of the Task Force; prohibiting a member of the Task Force from receiving certain compensation, but authorizing the reimbursement of certain expenses; requiring the Task Force to study certain matters related to a certain waiver application; requiring the Task Force to report its findings to the Governor and certain standing committees of the General Assembly on or before a certain date; providing for the termination of this Act; and generally relating to the Task Force to Evaluate the Impact of Maryland's Proposal to Maintain the Medicare Waiver.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:

(a) There is a Task Force to Evaluate the Impact of Maryland's Proposal to Maintain the Medicare Waiver.

(b) The Task Force consists of the following members:

(1) two members of the Senate of Maryland, one of whom shall be a member of the minority party, appointed by the President of the Senate;

(2) two members of the House of Delegates, one of whom shall be a member of the minority party, appointed by the Speaker of the House;

(3) the Secretary of Health and Mental Hygiene;

- (4) the Maryland Insurance Commissioner;
  - (5) the Executive Director of the Health Services Cost Review Commission;
  - (6) the Executive Director of the Maryland Health Care Commission;
  - (7) the Executive Director of the Maryland Health and Higher Educational Facilities Authority;
  - (8) three commissioners of the Health Services Cost Review Commission, appointed by the Executive Director of the Health Services Cost Review Commission;
  - (9) three representatives of the insurance industry in the State, including the Chief Executive Officer of CareFirst BlueCross BlueShield and the Chief Executive Officer of United Healthcare, appointed by the Maryland Insurance Commissioner; and
  - (10) the following members, appointed by the Governor:
    - (i) three representatives of the Maryland Hospital Association, including one representative of a hospital that is not affiliated with the University of Maryland Medical System, MedStar Health, or any other similar medical system;
    - (ii) two representatives of MedChi, the Maryland State Medical Society;
    - (iii) two representatives of the Maryland Nurses Association;and
    - (iv) two consumers of health care services.
- (c) The Governor shall appoint the members of the Task Force listed in subsection (b)(10)(i) through (iii) of this section from a list of names submitted by the organizations that the members represent.
- (d) The President of the Senate and the Speaker of the House each shall appoint a cochair of the Task Force.
- (e) The Health Services Cost Review Commission shall provide staff for the Task Force.
- (f) A member of the Task Force:
- (1) may not receive compensation as a member of the Task Force; but

(2) is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.

(g) The Task Force shall study:

(1) the Medicare waiver application submitted by the Department of Health and Mental Hygiene to the federal Centers for Medicare and Medicaid Services in March 2013 and its potential impact on:

- (i) general public health;
- (ii) health care planning;
- (iii) health care capital investments and finances;
- (iv) the provision of patient care, including inpatient and outpatient care;
- (v) insurance reimbursement rates;
- (vi) recruitment and retention of health care practitioners; and
- (vii) uncompensated care; and

(2) the impact of the implementation of the federal Patient Protection and Affordable Care Act on the Medicare waiver application.

(h) On or before January 1, 2014, the Task Force shall report its findings to the Governor and, in accordance with § 2-1246 of the State Government Article, the Senate Finance Committee and the House Health and Government Operations Committee.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2013. It shall remain effective for a period of 1 year and 1 month and, at the end of June 30, 2014, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
