# <u>AMENDMENTS TO HOUSE BILL 794</u> (First Reading File Bill)

#### AMENDMENT NO. 1

On page 1, in line 2, strike "Department of Planning –"; in line 4, after the first "of" insert "<u>establishing the Maryland Unaccompanied Homeless Youth and Young Adult Count Demonstration Project;</u>"; in the same line, strike "Planning" and substitute "<u>Housing and Community Development</u>"; in the same line, after "select" insert "<u>and monitor</u>"; strike beginning with "Maryland" in line 5 down through "Demonstration" in line 6; in line 10, strike "jurisdictions" and substitute "<u>Continuums of Care</u>"; in line 11, after "identifier;" insert "<u>requiring the Department of Planning to provide certain technical assistance</u>;"; in line 12, strike "Department" and substitute "<u>Departments</u>"; and in line 13, strike "providing for the termination of this Act;" and substitute "<u>requiring the coordinating entity to submit a certain report on or before a certain date; making this Act subject to a certain contingency;".</u>

#### AMENDMENT NO. 2

On page 1, strike beginning with "The" in line 18 down through "the" in line 19 and substitute "<u>There is a</u>"; strike beginning with the colon in line 21 down through "(1)" in line 22; in line 24, strike "; and" and substitute a period; and after line 24, insert:

"(c) (1) <u>The Department of Housing and Community Development shall</u> <u>select and monitor a coordinating entity to oversee the Project.</u>

(2) <u>The coordinating entity shall be selected through a competitive</u> request for proposal or by sole source contract.".

On page 2, strike in their entirety lines 1 through 5, inclusive; strike beginning with "the" in line 7 down through "County" in line 11 and substitute "<u>at least the</u>

following Continuums of Care established under Subtitle C of Title IV of the McKinney-Vento Homeless Assistance Act, 42 U.S.C. §§ 11381 through 11389:

(1) MD 501 – Baltimore City Continuum of Care;

- (2) MD 503 Annapolis/Anne Arundel County Continuum of Care;
- (3) MD 505 Baltimore County Continuum of Care;
- (4) MD 512 Hagerstown/Washington County Continuum of Care;
- (5) MD 513 Wicomico/Somerset/Worcester County Continuum of

Care; and

(6) <u>MD 600 – Prince George's County Continuum of Care</u>";

in line 13, after "entity" insert "<u>, in partnership with Continuums of Care and local</u> <u>communities</u>,"; strike line 18 in its entirety and substitute:

"(iii) <u>conduct a service provider count of unaccompanied homeless</u> youth; and";

and in lines 23 and 28, in each instance, strike "jurisdictions" and substitute "<u>communities</u>".

On page 3, in line 10, after "participants" insert "<u>and avoid duplication</u>"; after line 12, insert:

"(f) The Department of Planning shall:

(1) assist with presurvey data collection consultation and mapping support;

- (2) analyze and compile data after the survey is completed; and
- (3) provide a technical review of draft reports.";

in line 13, strike "(f)" and substitute "<u>(g)</u>"; in the same line, strike "Department" and substitute "<u>Departments</u>"; after line 16, insert:

"(h) On or before September 30, 2017, the coordinating entity shall submit a report to the General Assembly, in accordance with § 2-1246 of the State Government Article, on the results of the Project.";

in line 17, after "Act" insert "<u>is contingent on the receipt of funding from non-State</u> <u>sources to select a coordinating entity to oversee the Maryland Unaccompanied</u> <u>Homeless Youth and Young Adult Count Demonstration Project. The Department of</u> <u>Housing and Community Development shall notify the Department of Legislative</u> <u>Services within 5 days after funding is received. If notice of the receipt of funding is</u> <u>not received by the Department of Legislative Services on or before June 30, 2018, this</u> <u>Act shall be null and void without the necessity of further action by the General</u> <u>Assembly.</u>

<u>SECTION 3. AND BE IT FURTHER ENACTED, That, subject to the provisions</u> of Section 2 of this Act, this Act";

in line 18, strike "October" and substitute "<u>July</u>"; and strike beginning with "It" in line 18 down through "effect." in line 20.
