## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Zucker" and substitute "<u>Zucker, and Kramer</u>".

## AMENDMENT NO. 2

On page 1, in line 2, strike "Criminal Law – Crimes Committed" and substitute "<u>Crimes – Committing a Crime of Violence</u>"; strike beginning with "if" in line 3 down through "and" in line 4 and substitute "<u>when</u>"; in line 5, after "minor" insert "<u>of a</u> <u>certain age</u>"; in the same line, after "present" insert "<u>in a residence</u>"; in line 13, strike "crimes committed" and substitute "<u>the commission of crimes of violence</u>"; in line 14, strike "a minor" and substitute "<u>minors</u>"; and after line 14, insert:

"<u>BY repealing and reenacting, without amendments,</u> <u>Article – Courts and Judicial Proceedings</u> <u>Section 9-106(a)</u>

<u>Annotated Code of Maryland</u> (2013 Replacement Volume and 2013 Supplement)".

On page 2, strike in their entirety lines 1 through 5, inclusive.

#### AMENDMENT NO. 3

On page 2, after line 7, insert:

"<u>Article – Courts and Judicial Proceedings</u>

## HB0306/932314/1 Amendments to HB 306 Page 2 of 2

(a) The spouse of a person on trial for a crime may not be compelled to testify as an adverse witness unless the charge involves:

JUD

- (1) The abuse of a child under 18; or
- (2) Assault in any degree in which the spouse is a victim if:

(i) <u>The person on trial was previously charged with assault in</u> <u>any degree or assault and battery of the spouse;</u>

(ii) The spouse was sworn to testify at the previous trial; and

(iii) The spouse refused to testify at the previous trial on the basis of the provisions of this section.";

strike beginning with "THIS" in line 10 down through "(2)" in line 14; strike beginning with "IF" in line 15 down through "(II)" in line 18 and substitute "<u>WHEN</u>"; in line 19, after "MINOR" insert "<u>WHO IS AT LEAST 2 YEARS OLD</u>"; in the same line, after "PRESENT" insert "<u>IN A RESIDENCE</u>"; in line 20, strike "(3)" and substitute "(2)"; in the same line, after "OF" insert "<u>PARAGRAPH (1) OF</u>"; strike beginning with the second "OR" in line 21 down through "CRIME" in line 22 and substitute "<u>OF</u> <u>VIOLENCE</u>"; and in line 25, after "CRIME" insert "<u>OF VIOLENCE</u>".

On page 3, in line 1, strike "(A)(2)" and substitute "(A)(1)".

On page 4, strike in their entirety lines 8 through 23, inclusive.
