BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: Article - Election Law 16-401. A person may not willfully and knowingly: (a) give, transfer, promise, or offer anything of value for the purpose of
