A BILL ENTITLED

1 AN ACT concerning

2 **Open Meetings Act – Advance Notice of Meeting – Agenda**

3 FOR the purpose of requiring a public body to include an agenda containing certain
4 information in the advance notice of a meeting held by a certain public body;
5 and generally relating to notices of meetings held by public bodies.

6 BY repealing and reenacting, with amendments,

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article – State Government**

14 10–506.

15 (a) Before meeting in a closed or open session, a public body shall give
16 reasonable advance notice of the session.

17 (b) Whenever reasonable, a notice under this section shall:

18 (1) be in writing;

19 (2) include the date, time, and place of the session; [and]

1 **(3) INCLUDE AN AGENDA CONTAINING INFORMATION**
2 **SUFFICIENTLY DESCRIPTIVE TO INFORM THE PUBLIC OF THE MATTERS TO BE**
3 **DISCUSSED OR DECIDED AT THE MEETING; AND**

4 **[(3)] (4)** if appropriate, include a statement that a part or all of a
5 meeting may be conducted in closed session.

6 (c) A public body may give the notice under this section as follows:

7 (1) if the public body is a unit of the State government, by publication
8 in the Maryland Register;

9 (2) by delivery to representatives of the news media who regularly
10 report on sessions of the public body or the activities of the government of which the
11 public body is a part;

12 (3) if the public body previously has given public notice that this
13 method will be used:

14 (i) by posting or depositing the notice at a convenient public
15 location at or near the place of the session; or

16 (ii) by posting the notice on an Internet website ordinarily used
17 by the public body to provide information to the public; or

18 (4) by any other reasonable method.

19 (d) A public body shall keep a copy of a notice provided under this section for
20 at least 1 year after the date of the session.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 October 1, 2014.
