- FOR the purpose of changing the name of the Internal Investigative Unit in the Department of Public Safety and Correctional Services to the Intelligence and

6 7 8 9	(b) An investigator in the [Internal Investigative Unit] INTELLIGENCE AND INVESTIGATIVE DIVISION may exercise the powers of a peace or police officer in the State on property that is owned, leased, operated by, or under the control of the Department.
10 11 12 13	(c) (1) An investigator in the [Internal Investigative Unit] INTELLIGENCE AND INVESTIGATIVE DIVISION may exercise the powers of a peace or police officer in the State on property that is not owned, leased, operated by, or under the control of the Department when:
14	(i) engaged in fresh pursuit of a suspected offender;
15 16	(ii) requested or authorized to do so by the chief executive officer or chief police officer of a county;
17 18	(iii) necessary to facilitate the orderly flow of traffic to and from property owned, leased, operated by, or under the control of the Department;
19 20	(iv) necessary to investigate and protect property that is owned, leased, operated by, or under the control of the Department;
21 22 23	(v) engaged in an active and official investigation of the conduct of an employee of the Department when the employee's alleged conduct will compromise the safety or security of the Department's facilities or programs;
24 25 26 27 28	(vi) engaged in an active and official investigation of an inmate in the custody of the Commissioner of Correction or the Commissioner of Pretrial Detention and Services, an inmate subject to the jurisdiction of the Patuxent Institution, or an individual sentenced to probation or released on parole or mandatory supervision; or
29	(vii) ordered to do so by the Governor.
30 31 32 33	(2) When acting under the authority granted in this subsection in connection with an investigation or enforcement action, the [Internal Investigative Unit] INTELLIGENCE AND INVESTIGATIVE DIVISION shall notify the following persons:

3 4	(ii) when in a county that has a county police department, the chief of police or the chief's designee;
5 6	(iii) when in a county without a police department, the sheriff or the sheriff's designee;
7 8	(iv) when in Baltimore City, the Police Commissioner or the Police Commissioner's designee;
9 10 11	(v) when on any property owned, leased, operated by, or under the control of the Department of Natural Resources, the Secretary of Natural Resources or the Secretary's designee;
12 13 14 15	(vi) when on any property owned, leased, operated by, or under the control of the Maryland Transportation Authority, the Maryland Aviation Administration, or the Maryland Port Administration, the respective chief of police or the chief's designee; and

29 30 31 32	(5) A member of the [Internal Investigative Unit] INTELLIGENCE AND INVESTIGATIVE DIVISION who uses the authority granted in this subsection shall at all times and for all purposes remain an employee of the [Internal Investigative Unit] INTELLIGENCE AND INVESTIGATIVE DIVISION.

- 17 (m) On completion of an investigation and at least 20 days before a hearing, 18 the correctional officer under investigation shall be:
- 19 (1) notified of the name of each witness and of each charge and 20 specification against the correctional officer; and
  - (2) provided with a copy of the investigatory file and any exculpatory information, if the correctional officer and the correctional officer's counsel or representative agree to execute a confidentiality agreement with the appointing authority or the [Internal Investigative Unit] INTELLIGENCE AND INVESTIGATIVE DIVISION not to disclose any material contained in the investigatory file or exculpatory information for any purpose other than to defend the correctional officer.
- 27 (n) A person may not insert adverse material into a file of the correctional officer, except the file of the [Internal Investigative Unit] INTELLIGENCE AND INVESTIGATIVE DIVISION, unless the correctional officer has an opportunity to review, sign, receive a copy of, and comment in writing on the adverse material.
