A BILL ENTITLED

1 AN ACT concerning

2 **Adult Public Guardianship Review Board – Membership**

3 FOR the purpose of altering the membership requirements for adult public
4 guardianship review boards; and generally relating to adult public guardianship
5 review boards.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article – Family Law**

19 14–101.

20 (n) “Review board” means the adult public guardianship review board.

21 14–402.

22 (a) (1) Each review board consists of 11 members appointed:

- 1 (i) by the county commissioners;
- 2 (ii) in Baltimore City, by the Mayor with the advice and consent
3 of the City Council;
- 4 (iii) in any county that has a county executive, by the county
5 executive with the advice and consent of the county council; or
- 6 (iv) if 2 or more counties have agreed to establish a multicounty
7 review board, jointly by the appropriate officials of the counties served by the board.
- 8 (2) Of the 11 members:
- 9 (i) 1 shall be a professional representative of a local
10 department;
- 11 (ii) 1. in counties other than St. Mary's County[, 2 shall be
12 physicians, including 1 psychiatrist from a local health department that employs
13 psychiatrists]:
- 14 **A. 1 SHALL BE A PHYSICIAN'S ASSISTANT, NURSE**
15 **PRACTITIONER, OR PHYSICIAN WHO IS NOT A PSYCHIATRIST; AND**
- 16 **B. 1 SHALL BE A PSYCHIATRIST; and**
- 17 2. in St. Mary's County[.]:
- 18 **A. 1 shall be a PHYSICIAN'S ASSISTANT, NURSE**
19 **PRACTITIONER, OR physician [other than] WHO IS NOT a psychiatrist; and**
- 20 **B. 1 shall be a psychiatrist or psychologist;**
- 21 (iii) 1 shall be a representative of a local commission on aging;
- 22 (iv) 1 shall be a professional representative of a local nonprofit
23 social service organization;
- 24 (v) 1 shall be a lawyer;
- 25 (vi) 2 shall be lay individuals;
- 26 (vii) 1 shall be a [public health] **REGISTERED** nurse;
- 27 (viii) 1 shall be a professional in the field of disabilities; and

1 (ix) 1 shall be a person with a physical disability.

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
3 October 1, 2014.
