1 AN ACT concerning

2 **Election Law – Statewide Voter Registration List – Removal of Deceased**
3 **Voters**

4 FOR the purpose of requiring the State Administrator of Elections to make
5 arrangements with the Social Security Administration ~~to receive quarterly~~
6 ~~reports of names and residence addresses of certain individuals reported~~
7 ~~deceased and to obtain the reports within a certain period; requiring a local~~
8 ~~board of elections to remove a deceased voter from the statewide voter~~
9 ~~registration list under certain circumstances or a certain entity to receive~~
10 reports of certain individuals who are reported deceased; requiring an election
11 director to mail a certain notice on receipt of a certain report that a registered
12 voter is deceased; requiring an election director to take certain actions if the
13 election director receives a certain response to the notice; requiring an election
14 director to remove a registered voter who is reported deceased from the
15 statewide voter registration list if the election director does not receive a certain
16 response to the notice; and generally relating to the removal of deceased voters
17 from the statewide voter registration list.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
6 MARYLAND, That the Laws of Maryland read as follows:

7 **Article – Election Law**

8 3–501.

9 An election director may remove a voter from the statewide voter registration
10 list only:

11 (1) at the request of the voter, provided the request is:

12 (i) signed by the voter;

13 (ii) authenticated by the election director; and

14 (iii) in a format acceptable to the State Board or on a
15 cancellation notice provided by the voter on a voter registration application;

16 (2) upon determining, based on information provided pursuant to §
17 3–504 of this subtitle, that the voter is no longer eligible because:

18 (i) the voter is not qualified to be a registered voter as provided
19 in § 3–102(b) of this title; or

20 (ii) the voter is deceased;

21 (3) if the voter has moved outside the State, as determined by
22 conducting the procedures established in § 3–502 of this subtitle; or

23 (4) if, in accordance with the administrative complaint process under §
24 3–602 of this title, the State Administrator or the State Administrator’s designee has
25 determined that the voter is not qualified to be registered to vote.

27 (a) (1) (i) Information from the agencies specified in this paragraph
28 shall be reported to the State Administrator in a format and at times prescribed by the
29 State Board.

1 (ii) The Department of Health and Mental Hygiene shall report
2 the names and residence addresses (if known) of all individuals at least 16 years of age
3 reported deceased within the State since the date of the last report.

4 (iii) The clerk of the circuit court for each county and the
5 administrative clerk for each District Court shall report the names and addresses of
6 all individuals convicted, in the respective court, of a felony since the date of the last
7 report.

8 (iv) The clerk of the circuit court for each county shall report the
9 former and present names and residence addresses (if known) of all individuals whose
10 names have been changed by decree or order of the court since the date of the last
11 report.

12 (2) The State Administrator shall make arrangements with the clerk
13 of the United States District Court for the District of Maryland to receive reports of
14 names and addresses, if available, of individuals convicted of a felony in that court.

16 ~~(I) MAKE ARRANGEMENTS WITH THE SOCIAL SECURITY~~
17 ~~ADMINISTRATION TO RECEIVE QUARTERLY REPORTS OF NAMES AND~~
18 ~~RESIDENCE ADDRESSES OF ALL INDIVIDUALS AT LEAST 16 YEARS OF AGE WHO~~
19 ~~ARE DEEMED MARYLAND RESIDENTS AND REPORTED DECEASED; AND~~

20 ~~(II) PROMPTLY OBTAIN THE REPORTS AT THE END OF EACH~~
21 ~~QUARTER.~~

22 (3) THE STATE ADMINISTRATOR SHALL MAKE ARRANGEMENTS
23 WITH THE UNITED STATES SOCIAL SECURITY ADMINISTRATION OR AN ENTITY
24 THAT RECEIVES INFORMATION FROM THE SOCIAL SECURITY ADMINISTRATION
25 AND IS APPROVED BY THE STATE ADMINISTRATOR TO RECEIVE REPORTS OF
26 NAMES AND ADDRESSES, IF AVAILABLE, OF ALL MARYLAND RESIDENTS AT
27 LEAST 16 YEARS OF AGE WHO ARE REPORTED DECEASED.

28 (b) (1) The State Administrator shall transmit to the appropriate local
29 board information gathered pursuant to subsection (a) of this section.

30 (2) Every agency or instrumentality of any county which acquires or
31 condemns or razes or causes to be condemned or razed any building used as a
32 residence within the county shall promptly report this fact and the location of the
33 building to the local board in the county or city.

34 (3) Registration cancellation information provided by an applicant on
35 any voter registration application shall be provided to the appropriate local board by
36 the State Administrator or another local board.

1 (4) A local board may:

2 (i) make arrangements to receive change of address
3 information from an entity approved by the State Board; and

4 (ii) pay a reasonable fee to the entity for the information.

5 (c) (1) (I) [Whenever] **EXCEPT AS PROVIDED IN PARAGRAPH (2) OF**
6 **THIS SUBSECTION, WHENEVER** a local board becomes aware of an obituary or any
7 other reliable report of the death of a registered voter, the election director shall mail
8 a notice to the registered voter, as prescribed by the State Board, to verify whether the
9 voter is in fact deceased.

10 [(2)] (II) On receipt of a verification of the death of a voter, provided
11 in accordance with the notice mailed under [paragraph (1) of this subsection]
12 **SUBPARAGRAPH (I) OF THIS PARAGRAPH**, the election director may remove the
13 voter from the statewide voter registration list under § 3-501 of this subtitle.

14 (2) (I) **WHENEVER A LOCAL BOARD RECEIVES A ~~SOCIAL~~**
15 **~~SECURITY ADMINISTRATION~~ REPORT OBTAINED BY THE STATE**
16 **ADMINISTRATOR UNDER SUBSECTION (A)(3) OF THIS SECTION THAT INCLUDES**
17 **A REGISTERED VOTER, THE ELECTION DIRECTOR ~~SHALL REMOVE THE VOTER~~**
18 **~~FROM THE STATEWIDE VOTER REGISTRATION LIST UNDER § 3-501 OF THIS~~**
19 **SUBTITLE SHALL MAIL TO THE ADDRESS SHOWN ON THE STATEWIDE VOTER**
20 **REGISTRATION LIST, BY REGULAR U.S. MAIL, A NOTICE THAT:**

21 **1. STATES THAT THE REGISTERED VOTER HAS BEEN**
22 **REPORTED BY THE SOCIAL SECURITY ADMINISTRATION TO HAVE DIED; AND**

23 **2. NOTIFIES THE REGISTERED VOTER OR A PERSON**
24 **ATTENDING THE AFFAIRS OF A DECEASED VOTER THAT THE VOTER WILL BE**
25 **REMOVED FROM THE STATEWIDE VOTER REGISTRATION LIST UNLESS, WITHIN 2**
26 **WEEKS AFTER THE DATE OF THE LETTER, THE REGISTERED VOTER OR A**
27 **REPRESENTATIVE:**

28 **A. OBJECTS TO THE REMOVAL; AND**

29 **B. SHOWS CAUSE WHY THE REMOVAL SHOULD NOT**
30 **PROCEED.**

31 **(II) IF THE REGISTERED VOTER OR A REPRESENTATIVE**
32 **TIMELY OBJECTS AND SHOWS CAUSE WHY THE REMOVAL SHOULD NOT**
33 **PROCEED, THE ELECTION DIRECTOR MAY:**

1 **1. TERMINATE THE REMOVAL PROCESS AND RETAIN**
2 **THE REGISTERED VOTER ON THE STATEWIDE VOTER REGISTRATION LIST; OR**

3 **2. REFER THE MATTER TO THE LOCAL BOARD FOR A**
4 **HEARING TO DETERMINE THE REGISTERED VOTER’S STATUS.**

5 **(III) IF THE REGISTERED VOTER OR A REPRESENTATIVE**
6 **FAILS TO TIMELY OBJECT AND SHOW CAUSE WHY THE REMOVAL SHOULD NOT**
7 **PROCEED, THE REGISTRATION SHALL BE CANCELED AND THE REGISTERED**
8 **VOTER REMOVED FROM THE STATEWIDE VOTER REGISTRATION LIST.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 June 1, 2014.
