CHAPTER _____

1 AN ACT concerning

2 **Elevator Safety Review Board and Division of Labor and Industry – Sunset**
3 **Extension and Program Evaluation**

4 FOR the purpose of continuing the Elevator Safety Review Board in accordance with
5 the provisions of the Maryland Program Evaluation Act (sunset law) by
6 extending to a certain date the termination provisions relating to the statutory
7 and regulatory authority of the Board; requiring that an evaluation of the Board
8 and the statutes and regulations that govern the Board be performed on or
9 before a certain date; repealing certain termination provisions that apply to the
10 regulation of mediation or arbitration of labor disputes, choice of bargaining
11 representative, and strikebreakers; providing for the effective date of this Act;
12 and generally relating to the Elevator Safety Review Board and the Division of
13 Labor and Industry.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article – Labor and Employment**

14 [4–405.

15 Subject to the evaluation and reestablishment provisions of the Maryland
16 Program Evaluation Act, Subtitles 1 and 2 of this title and § 4–403 of this subtitle
17 shall terminate and be of no effect after July 1, 2014.]

18 **Article – Public Safety**

19 12–842.

20 Subject to the evaluation and reestablishment provisions of the Maryland
21 Program Evaluation Act, the provisions of this title that create or relate to the Board
22 and any regulations adopted by the Board shall terminate and be of no effect after
23 July 1, [2014] **2019**.

24 **Article – State Government**

25 8–403.

26 (a) On or before December 15 of the evaluation year specified, the
27 Department shall:

28 (1) conduct a preliminary evaluation of each governmental activity or
29 unit to be evaluated under this section; and

30 (2) prepare a report on each preliminary evaluation conducted.

1 (b) Each of the following governmental activities or units and the statutes
2 and regulations that relate to the governmental activities or units are subject to
3 preliminary evaluation in the evaluation year specified:

4 (16) Elevator Safety Review Board (§§ 12-819 through 12-841 of the
5 Public Safety Article: **[2011] 2016**);

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 June 30, 2014.
