A BILL ENTITLED

1 AN ACT concerning

State Board of Audiologists, Hearing Aid Dispensers, and Speech–Language Pathologists – Sunset Extension and Program Evaluation

- 4 FOR the purpose of continuing the State Board of Audiologists, Hearing Aid $\mathbf{5}$ Dispensers, and Speech-Language Pathologists in accordance with the 6 provisions of the Maryland Program Evaluation Act (sunset law) by extending 7 to a certain date the termination provisions relating to the statutory and 8 regulatory authority of the Board; requiring that an evaluation of the Board and 9 the statutes and regulations that relate to the Board be performed on or before a certain date: requiring the Board to submit a certain report to certain 10 committees of the General Assembly on or before a certain date; and generally 11 12relating to the State Board of Audiologists, Hearing Aid Dispensers, and Speech-Language Pathologists. 13
