# Charles County - Sunday Car Sales - Sales Blue Law Exemption - Enabling <u>Authority</u>

FOR the purpose of authorizing <u>the Charles County Commissioners to adopt an</u>
<u>ordinance authorizing</u> a new or used car dealer in Charles County to sell,
barter, deliver, give away, show, or offer for sale a motor vehicle or certificate of
title for a motor vehicle on Sunday; and generally relating to <u>enabling authority</u>
for Sunday car sales in Charles County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That the Laws of Maryland read as follows:

#### Article – Business Regulation

18 (a) (1) This section does not apply to the laws that relate to the sale of 19 alcoholic beverages.

15 16 17	(e) In Anne Arundel County, a dealer may sell, barter, deliver, give away, show, or offer for sale on Sunday a new or used camping trailer, mobile home, or travel trailer, as those terms are defined in Title 11 of the Transportation Article.
18 19	(f) A new or used car dealer who violates subsection (d) of this section is guilty of a misdemeanor and, on conviction, is subject to a fine not exceeding \$10,000.
$20 \\ 21 \\ 22$	(g) In Anne Arundel County and Worcester County, a dealer may sell, barter, deliver, give away, show, or offer for sale a motorcycle, as defined in § 11–136 of the Transportation Article, or certificate of title for a motorcycle on Sunday.
23 24 25 26	(h) In Baltimore City, a used car dealer may sell, barter, deliver, give away, show, or offer for sale a motor vehicle or certificate of title for a motor vehicle on Sunday, instead of Saturday, if the dealer notifies the Motor Vehicle Administration in advance that the dealer intends to conduct business on Sunday, instead of Saturday.
27	(I) IN CHARLES COUNTY, THE COUNTY COMMISSIONERS MAY ADOPT
28	AN ORDINANCE AUTHORIZING A NEW OR USED CAR DEALER TO SELL, BARTER,
