Truant Students - System of Active Intervention - Requirements

- FOR the purpose of requiring the system of active intervention for certain truant 3 students developed by each county board of education to include an 4 5 Individualized Reengagement Plan for each truant student, coordination and 6 collaboration with State and municipal agencies to deliver certain services, 7 creation of a certain database to track truant students, and a specific plan for 8 each public school to reengage truant students; requiring the Individualized 9 Reengagement Plan to be developed by certain individuals using a certain process and requiring the Plan to be customized to the student; defining certain 10 terms; and generally relating to requirements for a system of active 11 12 intervention for truant students.

- 5 (3) "TRUANCY ACTION PLANNING" MEANS A SYSTEMIC PROCESS
