## Creation of a State Debt – Howard County – Day Resource Center

Ho. Co. 4–14

FOR the purpose of authorizing the creation of a State Debt not to exceed \$575,000,
the proceeds to be used as a grant to the County Executive and County Council
of Howard County for certain development or improvement purposes; providing
for disbursement of the loan proceeds, subject to a requirement that the grantee
provide and expend a matching fund; establishing a deadline for the
encumbrance or expenditure of the loan proceeds; and providing generally for
the issuance and sale of bonds evidencing the loan.

#### 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That:

13The Board of Public Works may borrow money and incur indebtedness on (1)14behalf of the State of Maryland through a State loan to be known as the Howard County – Day Resource Center Loan of 2014 in a total principal amount equal to the 15lesser of (i) \$575,000 or (ii) the amount of the matching fund provided in accordance 16 with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and 17 18 delivery of State general obligation bonds authorized by a resolution of the Board of 19Public Works and issued, sold, and delivered in accordance with §§ 8-117 through 208–124 and 8–131.2 of the State Finance and Procurement Article.

21 (2) The bonds to evidence this loan or installments of this loan may be sold 22 as a single issue or may be consolidated and sold as part of a single issue of bonds 23 under § 8–122 of the State Finance and Procurement Article.

(3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
and first shall be applied to the payment of the expenses of issuing, selling, and
delivering the bonds, unless funds for this purpose are otherwise provided, and then

1 shall be credited on the books of the Comptroller and expended, on approval by the 2 Board of Public Works, for the following public purposes, including any applicable 3 architects' and engineers' fees: as a grant to the County Executive and County Council 4 of Howard County (referred to hereafter in this Act as "the grantee") for the 5 acquisition, planning, design, construction, repair, renovation, reconstruction, and 6 capital equipping of the Day Resource Center, located in Howard County.

7 (4) An annual State tax is imposed on all assessable property in the State in 8 rate and amount sufficient to pay the principal of and interest on the bonds, as and 9 when due and until paid in full. The principal shall be discharged within 15 years 10 after the date of issuance of the bonds.

Prior to the payment of any funds under the provisions of this Act for the 11 (5)12purposes set forth in Section 1(3) above, the grantee shall provide and expend a 13matching fund. No part of the grantee's matching fund may be provided, either directly or indirectly, from funds of the State, whether appropriated or 1415unappropriated. No part of the fund may consist of real property, in kind contributions, or funds expended prior to the effective date of this Act. In case of any 16dispute as to the amount of the matching fund or what money or assets may qualify as 17matching funds, the Board of Public Works shall determine the matter and the 18Board's decision is final. The grantee has until June 1, 2016, to present evidence 1920 satisfactory to the Board of Public Works that a matching fund will be provided. If 21satisfactory evidence is presented, the Board shall certify this fact and the amount of 22the matching fund to the State Treasurer, and the proceeds of the loan equal to the 23amount of the matching fund shall be expended for the purposes provided in this Act. 24Any amount of the loan in excess of the amount of the matching fund certified by the 25Board of Public Works shall be canceled and be of no further effect.

(6) The proceeds of the loan must be expended or encumbered by the Board
of Public Works for the purposes provided in this Act no later than June 1, 2021. If any
funds authorized by this Act remain unexpended or unencumbered after June 1, 2021,
the amount of the unencumbered or unexpended authorization shall be canceled and
be of no further effect. If bonds have been issued for the loan, the amount of
unexpended or unencumbered bond proceeds shall be disposed of as provided in
§ 8–129 of the State Finance and Procurement Article.

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 34 June 1, 2014.
