## A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Country Inn Licenses**

3 FOR the purpose of authorizing the Board of License Commissioners of Frederick  
4 County to issue a Class B–CI (country inn) on–sale beer, wine and liquor license  
5 for the use of an establishment that meets certain requirements in a certain  
6 election district; and generally relating to alcoholic beverages licenses in  
7 Frederick County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B – Alcoholic Beverages**

21 8–211.

22 (a) The provisions of this section apply only in Frederick County.

1           (c) **(1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**  
2 **SUBSECTION, Class A, B, and C licenses for the sale of beer only, as authorized by**  
3 **this article, shall be issued for places of business located in any of the following**  
4 **election districts:**

5                   **[(1)] (I) Jefferson (14th);**

6                   **[(2)] (II) Johnsville (17th); and**

7                   **[(3)] (III) Burkittsville (22nd).**

8                   **(2) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A**  
9 **CLASS B-CI (COUNTRY INN) ON-SALE BEER, WINE AND LIQUOR LICENSE FOR**  
10 **THE USE OF AN ESTABLISHMENT THAT MEETS THE REQUIREMENTS OF §**  
11 **6-201(L)(7)(I) OF THIS ARTICLE IN THE BURKITTSVILLE (22ND) ELECTION**  
12 **DISTRICT.**

13           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14 July 1, 2014.
