Office of the Attorney General – Establishment of a Consumer Affairs Satellite Office in Prince George's County

4 FOR the purpose of requiring the Office of the Attorney General to establish a 5 consumer affairs satellite office in Prince George's County; providing for the 6 purpose of establishing the consumer affairs satellite office; requiring the 7 consumer affairs satellite office to provide consumers with certain resources; 8 requiring the Office of the Attorney General to give priority to a certain site in 9 determining where to locate the consumer affairs satellite office; requiring the 10 Office of the Attorney General, on or before a certain date, to report to the 11 Governor and the General Assembly on the operations of the consumer affairs 12 satellite office; and generally relating to the establishment by the Office of the 13 Attorney General of a consumer affairs satellite office in Prince George's 14 County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That:

(a) On or before October 1, 2014, the Office of the Attorney General shall establish a consumer affairs satellite office in Prince George's County.
