A BILL ENTITLED

1 AN ACT concerning

2 **State Government – Inspector General**

3 FOR the purpose of specifying that there is an Inspector General of the State;
4 specifying the Inspector General's annual salary; providing that the Inspector
5 General is entitled to certain reimbursement; establishing the Office of the
6 Inspector General; authorizing the Inspector General to have certain offices and
7 employ certain staff; requiring certain staff to perform certain duties and to
8 carry certain identification; specifying that certain staff serve at the pleasure of
9 the Inspector General and are entitled to certain compensation and
10 reimbursement; authorizing the Inspector General to designate a certain Chief
11 Deputy Inspector General and certain other deputy inspectors general;
12 requiring the Chief Deputy Inspector General to serve as acting Inspector
13 General for a certain period under certain circumstances; authorizing the
14 Inspector General to adopt certain regulations and assist in a certain
15 investigation or conduct a joint investigation with certain entities; requiring the
16 Inspector General to develop a certain operations manual, make the operations
17 manual available to the public, and provide certain training; requiring the
18 Inspector General to examine and investigate the management and affairs of
19 units and conduct audits of the units; authorizing the Inspector General to
20 investigate certain matters; requiring the Inspector General periodically to
21 review certain policies and procedures and make certain recommendations;
22 requiring the Inspector General to receive certain complaints and establish a
23 certain hotline number and Web site; requiring the Inspector General to take
24 certain action when the Inspector General receives a complaint or discovers
25 certain evidence; requiring that a unit cooperate fully with the Inspector
26 General under certain circumstances; requiring that the Inspector General have
27 access to certain documents of a unit under certain circumstances; authorizing
28 the Inspector General, or the Inspector General's designee, to take certain

1 action in the performance of certain duties; specifying the process under which
 2 the Inspector General is authorized to issue a subpoena or subpoena duces
 3 tecum; authorizing a subpoena to be served by certain methods; authorizing a
 4 certain judge to take certain action if a person refuses to obey a certain
 5 subpoena; providing that, under certain circumstances, certain records are
 6 confidential and not subject to disclosure under a certain provision of law until a
 7 certain report is issued; requiring the Inspector General, at the end of each
 8 fiscal year, to submit a certain annual report to the Governor and the General
 9 Assembly; requiring the Inspector General to issue a certain final report;
 10 requiring that the final report be submitted to the Governor and the General
 11 Assembly and be posted on a certain Web site; requiring that the Inspector
 12 General, except under certain circumstances, provide a certain unit an
 13 opportunity to respond to a certain report; authorizing that certain special
 14 elections be held to fill a certain vacancy; requiring that certain special elections
 15 be held at a time specified in a certain provision of this Act; requiring the State
 16 Board of Elections to determine the dates that certain elections are to be held;
 17 requiring that a certain primary election be held at least a certain number of
 18 days after a certain vacancy occurs; requiring that a certain general election be
 19 held at least a certain number of days after a certain primary election is held;
 20 making this Act contingent on the passage and ratification of a certain
 21 constitutional amendment; defining certain terms; and generally relating to the
 22 Inspector General.

6 **(C) “UNIT” MEANS AN AGENCY OR A UNIT OF THE EXECUTIVE BRANCH**
7 **OF STATE GOVERNMENT.**

9 **(A) THERE IS AN INSPECTOR GENERAL OF THE STATE, AS PROVIDED IN**
10 **ARTICLE XX, § 1 OF THE MARYLAND CONSTITUTION.**

11 **(B) THE INSPECTOR GENERAL’S ANNUAL SALARY SHALL BE:**

12 **(1) \$112,500 FOR THE FIRST YEAR OF THE TERM BEGINNING**
13 **JANUARY 2015;**

14 **(2) \$116,667 STARTING ON THE FIRST ANNIVERSARY OF THE**
15 **BEGINNING OF THE TERM;**

16 **(3) \$120,833 STARTING ON THE SECOND ANNIVERSARY OF THE**
17 **BEGINNING OF THE TERM; AND**

18 **(4) \$125,000 STARTING ON THE THIRD ANNIVERSARY OF THE**
19 **BEGINNING OF THE TERM AND THEREAFTER.**

20 **(C) THE INSPECTOR GENERAL IS ALSO ENTITLED TO REIMBURSEMENT**
21 **FOR TRAVEL AND OTHER EXPENSES THAT ARE CONNECTED WITH THE DUTIES**
22 **OF THE OFFICE.**

26 **(3) UNAUTHORIZED USE OF LEAVE BY STATE EMPLOYEES;**

- 1 **(4) MISMANAGEMENT OF GOVERNMENTAL OPERATIONS;**
2 **(5) WASTE OR ABUSE OF PROPERTY BELONGING TO A UNIT; AND**
3 **(6) CONSTRUCTION, OPERATION, AND MAINTENANCE OF STATE**

18 **(C) IF THE INSPECTOR GENERAL DISCOVERS EVIDENCE OF CRIMINAL**
19 **ACTIVITY WHEN INVESTIGATING A COMPLAINT, THE INSPECTOR GENERAL**
20 **SHALL NOTIFY THE APPROPRIATE LAW ENFORCEMENT AGENCY.**

22 **(A) A UNIT SHALL COOPERATE FULLY WITH THE INSPECTOR GENERAL**
23 **IN AN INVESTIGATION OR AUDIT THAT IS CONDUCTED BY THE OFFICE.**

24 **(B) THE INSPECTOR GENERAL SHALL HAVE ACCESS TO ALL RECORDS,**
25 **DATA, REPORTS, CONTRACTS, CORRESPONDENCE, OR OTHER DOCUMENTS OF A**
26 **UNIT DURING AN INVESTIGATION OR AUDIT CONDUCTED BY THE OFFICE.**

1 **(A) IN THE PERFORMANCE OF THE DUTIES OF THE INSPECTOR**
2 **GENERAL, THE INSPECTOR GENERAL OR THE INSPECTOR GENERAL'S**
3 **DESIGNEE MAY:**

4 **(1) SEEK AND OBTAIN SWORN TESTIMONY;**

5 **(2) COMPEL THE ATTENDANCE OF WITNESSES TO BE DEPOSED BY**
6 **THE OFFICE; AND**

7 **(3) COMPEL THE PRODUCTION OF RECORDS BY ISSUING A**
8 **SUBPOENA IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION.**

9 **(B) (1) THE INSPECTOR GENERAL MAY ISSUE A SUBPOENA OR**
10 **SUBPOENA DUCES TECUM ONLY WITH THE APPROVAL OF A JUDGE OF THE**
11 **CIRCUIT COURT FOR THE COUNTY IN WHICH THE OFFICE IS LOCATED.**

12 **(2) THE INSPECTOR GENERAL SHALL SUBMIT A WRITTEN**
13 **APPLICATION FOR THE APPROVAL SOUGHT UNDER PARAGRAPH (1) OF THIS**
14 **SUBSECTION.**

15 **(3) A WRITTEN DECISION ON AN APPLICATION SUBMITTED**
16 **UNDER PARAGRAPH (2) OF THIS SUBSECTION SHALL BE ISSUED WITHIN 72**
17 **HOURS AFTER THE RECEIPT OF THE APPLICATION.**

18 **(4) A SUBPOENA FOR PRODUCTION OF RECORDS MAY BE SERVED**
19 **BY:**

20 **(I) CERTIFIED MAIL, RETURN RECEIPT REQUESTED, AT THE**
21 **ADDRESSEE'S RESIDENCE OR BUSINESS ADDRESS;**

22 **(II) A REPRESENTATIVE APPOINTED BY THE INSPECTOR**
23 **GENERAL; OR**

24 **(III) THE APPROPRIATE LAW ENFORCEMENT AGENCY.**

25 **(C) IF A PERSON REFUSES TO OBEY A SUBPOENA ISSUED BY THE**
26 **INSPECTOR GENERAL UNDER SUBSECTION (B) OF THIS SECTION, THE JUDGE**
27 **THAT APPROVED THE ISSUANCE OF THE SUBPOENA UNDER SUBSECTION (B) OF**
28 **THIS SECTION MAY:**

29 **(1) ISSUE AN ORDER TO THE PERSON REQUIRING THE PERSON TO**
30 **APPEAR BEFORE THE COURT TO SHOW CAUSE; AND**

1 **(2) FIND THE PERSON IN CONTEMPT OF COURT.**

2 **7.5-111.**

3 **(A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION,**
4 **RECORDS PREPARED OR OBTAINED BY THE INSPECTOR GENERAL IN**
5 **CONNECTION WITH AN INVESTIGATION OR AUDIT CONDUCTED BY THE OFFICE**
6 **ARE CONFIDENTIAL AND NOT SUBJECT TO DISCLOSURE UNDER THE PUBLIC**
7 **INFORMATION ACT UNTIL THE FINAL REPORT ON THE INVESTIGATION OR**
8 **AUDIT IS ISSUED UNDER § 7.5-112 OF THIS TITLE.**

9 **(B) IF AN INDIVIDUAL REQUESTS A PUBLIC RECORD UNDER THE**
10 **PUBLIC INFORMATION ACT AND THE ONLY COPY OF THE PUBLIC RECORD HAS**
11 **BEEN OBTAINED BY THE INSPECTOR GENERAL, THE CUSTODIAN OF THE PUBLIC**
12 **RECORD SHALL CERTIFY THAT THE INSPECTOR GENERAL IS IN POSSESSION OF**
13 **THE ONLY COPY OF THE RECORD AND THE INSPECTOR GENERAL SHALL ALLOW**
14 **THE INDIVIDUAL TO EXAMINE AND COPY THE RECORD.**

15 **(C) AN INDIVIDUAL WHO DISCLOSES A RECORD PROTECTED FROM**
16 **DISCLOSURE UNDER THIS SECTION IS GUILTY OF A MISDEMEANOR AND IS**
17 **SUBJECT TO A FINE NOT TO EXCEED \$2,000 OR IMPRISONMENT NOT TO EXCEED**
18 **1 YEAR OR BOTH.**

20 **(A) (1) AT THE END OF EACH FISCAL YEAR, THE INSPECTOR**
21 **GENERAL SHALL SUBMIT AN ANNUAL REPORT TO THE GOVERNOR AND, IN**
22 **ACCORDANCE WITH § 2-1246 OF THIS ARTICLE, THE GENERAL ASSEMBLY.**

23 **(2) THE ANNUAL REPORT SHALL:**

24 **(I) DESCRIBE THE BUSINESS AND PROCEEDINGS OF THE**
25 **OFFICE DURING THE PRECEDING FISCAL YEAR; AND**

26 **(II) INCLUDE ANY RECOMMENDATIONS REGARDING THE**
27 **ACTIVITIES OF THE UNITS THAT THE INSPECTOR GENERAL CONSIDERS**
28 **APPROPRIATE.**

29 **(B) (1) THE INSPECTOR GENERAL SHALL ISSUE A FINAL REPORT ON**
30 **AN INVESTIGATION OR AUDIT COMPLETED BY THE OFFICE.**

31 **(2) THE FINAL REPORT ISSUED UNDER PARAGRAPH (1) OF THIS**
32 **SUBSECTION SHALL:**

1 (I) BE SUBMITTED TO THE GOVERNOR AND, IN
2 ACCORDANCE WITH § 2-1246 OF THIS ARTICLE, THE GENERAL ASSEMBLY; AND

3 (II) BE POSTED ON THE OFFICE'S WEB SITE.

4 (3) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS
5 PARAGRAPH, BEFORE RELEASING A FINAL REPORT UNDER PARAGRAPH (1) OF
6 THIS SUBSECTION, THE INSPECTOR GENERAL SHALL PROVIDE AN
7 OPPORTUNITY FOR THE UNIT THAT WAS THE SUBJECT OF THE INVESTIGATION
8 OR AUDIT TO RESPOND TO THE REPORT.

9 (II) THE INSPECTOR GENERAL IS NOT REQUIRED TO
10 PROVIDE AN OPPORTUNITY FOR RESPONSE UNDER SUBPARAGRAPH (I) OF THIS
11 PARAGRAPH IF THE INSPECTOR GENERAL, IN CONJUNCTION WITH A UNITED
12 STATES ATTORNEY, AN ATTORNEY GENERAL, A STATE'S ATTORNEY, OR ANY
13 OTHER APPROPRIATE PROSECUTORIAL AGENCY, DETERMINES THAT ALLOWING
14 THE UNIT TO RESPOND WOULD JEOPARDIZE A PENDING OR POTENTIAL
15 CRIMINAL INVESTIGATION.

17 8-401.

18 (a) A special primary election and a special general election may be held at a
19 time other than the date of a regular primary election and a regular general election:

20 (1) to fill a vacancy in the office of Representative in Congress; [or]

21 (2) to fill a vacancy in the county council if the charter of that county
22 provides for special elections; OR

23 (3) TO FILL A VACANCY IN THE OFFICE OF THE INSPECTOR
24 GENERAL IF THE VACANCY OCCURS MORE THAN 2 YEARS BEFORE THE
25 EXPIRATION OF THE INSPECTOR GENERAL'S TERM.

26 (b) (1) Special elections to fill a vacancy in the office of Representative in
27 Congress shall be held at the time specified in Subtitle 7 of this title.

28 (2) Special elections to fill vacancies in a county council shall be held
29 as provided in the county charter.

30 (3) SPECIAL ELECTIONS TO FILL A VACANCY IN THE OFFICE OF
31 THE INSPECTOR GENERAL SHALL BE HELD AT THE TIME SPECIFIED IN § 8-402
32 OF THIS SUBTITLE.

1 (c) An election to fill a vacancy in the office of United States Senator shall be
2 held concurrently with a regular election as provided in Subtitle 6 of this title.

3 **8-402.**

4 (A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, THE STATE BOARD
5 SHALL DETERMINE THE DATES OF THE SPECIAL PRIMARY ELECTION AND THE
6 SPECIAL GENERAL ELECTION TO BE HELD TO FILL A VACANCY IN THE OFFICE
7 OF THE INSPECTOR GENERAL.

8 (B) (1) THE SPECIAL PRIMARY ELECTION SHALL BE HELD ON A
9 TUESDAY THAT IS AT LEAST 36 DAYS AFTER THE DATE THAT THE VACANCY
10 OCCURS.

11 (2) THE SPECIAL GENERAL ELECTION SHALL BE HELD ON A
12 TUESDAY THAT IS A LEAST 36 DAYS AFTER THE DATE OF THE SPECIAL PRIMARY
13 ELECTION.

14 (C) THE STATE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT
15 THIS SECTION.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is contingent on
17 the passage of Chapter ___(S.B.___/H.B.___)(4lr1010) of the Acts of the General
18 Assembly of 2014, a constitutional amendment, and its ratification by the voters of the
19 State.

20 SECTION 3. AND BE IT FURTHER ENACTED, That, subject to the provisions
21 of Section 2 of this Act, this Act shall take effect on the proclamation of the Governor
22 that the constitutional amendment, having received a majority of the votes cast at the
23 general election, has been adopted by the people of Maryland.
