Commission on Tax Policy, Reform, and Fairness

- 3 FOR the purpose of establishing the Commission on Tax Policy, Reform, and Fairness; 4 specifying the membership of the Commission; providing for the appointment of a Senate cochair and House cochair of the Commission; providing for the $\mathbf{5}$ 6 staffing of the Commission; prohibiting a member of the Commission from 7 receiving certain compensation, but authorizing the reimbursement of certain 8 expenses; requiring the Commission to study. consider. and make 9 recommendations regarding certain matters; requiring the Commission to report its findings and recommendations to the Governor and the General 10 Assembly on or before a certain date; providing for the termination of this Act; 11 and generally relating to the Commission on Tax Policy, Reform, and Fairness. 12
- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That:
- 15 (a) There is a Commission on Tax Policy, Reform, and Fairness.
- 16 (b) The Commission consists of the following members:
- 17 (1) two members of the Senate of Maryland, appointed by the 18 President of the Senate;
- 19 (2) two members of the House of Delegates, appointed by the Speaker20 of the House;

and recommendations to the Governor and, in accordance with § 2–1246 of the State
Government Article, the General Assembly.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 July 1, 2014. It shall remain effective for a period of 2 years and, at the end of June 17 30, 2016, with no further action required by the General Assembly, this Act shall be 18 abrogated and of no further force and effect.
