2 Anne Arundel County – Alcoholic Beverages – Tasting Licenses

FOR the purpose of creating in Anne Arundel County a BWST beer, wine and spirits
tasting (on-premises) license; specifying that the BWST license may be issued
to certain persons; creating a license fee schedule for a BWST license and
altering the fee schedule for a BWT beer and wine (on-premises) tasting license;
specifying certain limitations on the amount of alcoholic beverages that may be
offered for on-premises consumption; and generally relating to alcoholic
beverages licenses in Anne Arundel County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows:
