## HOUSE BILL 670

1 (3) [(i)] For archery hunters [in Carroll County or Frederick 2 County], the safety zone described in paragraph (1) of this subsection extends for 50 3 yards from a dwelling house, residence, church, or any other building or camp occupied 4 by human beings.

5 [(ii) For archery hunters in Harford County, the safety zone 6 described in paragraph (1) of this subsection extends for 100 yards from a dwelling 7 house, residence, church, or any other building or camp occupied by human beings.]

8 (4) During any open hunting season, a person, other than the owner or 9 occupant, may not hunt or chase willfully any wild bird or mammal within the safety 10 zone without the specific advance permission of the owner or occupant.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 July 1, 2014.
