## A BILL ENTITLED

1 AN ACT concerning

2 **Crimes – Threat of Mass Violence**

3 FOR the purpose of prohibiting a person from threatening to commit or causing to be  
4 committed a certain crime of violence that would place others at substantial risk  
5 of death or serious physical injury if there are certain probable consequences of  
6 the threat; establishing that this Act applies to a threat made by oral or written  
7 communication or electronic mail; establishing that a person who violates this  
8 Act is guilty of the misdemeanor of making a threat of mass violence;  
9 establishing a penalty for a violation of this Act; requiring a court to order a  
10 person convicted under this Act to reimburse certain persons; providing for the  
11 venue for a prosecution under this Act; defining certain terms; and generally  
12 relating to the misdemeanor of making a threat of mass violence.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article – Criminal Law**

22 **SUBTITLE 10. THREAT OF MASS VIOLENCE.**

1           **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**  
2 **MEANINGS INDICATED.**

3                   **(2) “DWELLING” HAS THE MEANING STATED IN § 6–201 OF THIS**  
4 **ARTICLE.**

5                   **(3) “PUBLIC PLACE” HAS THE MEANING STATED IN § 10–201 OF**  
6 **THIS ARTICLE.**

7                   **(4) “STOREHOUSE” HAS THE MEANING STATED IN § 6–201 OF**  
8 **THIS ARTICLE.**

9           **(B) THIS SECTION APPLIES TO A THREAT MADE BY ORAL OR WRITTEN**  
10 **COMMUNICATION OR ELECTRONIC MAIL, AS DEFINED IN § 3–805(A) OF THIS**  
11 **TITLE.**

12           **(C) A PERSON MAY NOT KNOWINGLY THREATEN TO COMMIT OR CAUSE**  
13 **TO BE COMMITTED A CRIME OF VIOLENCE, AS DEFINED IN § 14–101 OF THIS**  
14 **ARTICLE, THAT WOULD PLACE OTHERS AT SUBSTANTIAL RISK OF DEATH OR**  
15 **SERIOUS PHYSICAL INJURY, AS DEFINED IN § 3–201 OF THIS TITLE, IF THE**  
16 **NATURAL AND PROBABLE CONSEQUENCE OF THE THREAT, REGARDLESS OF**  
17 **WHETHER THE CONSEQUENCE OCCURS, WOULD BE THAT FIVE OR MORE PEOPLE**  
18 **COULD BE:**

19                   **(1) PLACED IN REASONABLE FEAR THAT THE CRIME WILL BE**  
20 **COMMITTED;**

21                   **(2) REQUIRED TO EVACUATE FROM A DWELLING, STOREHOUSE,**  
22 **OR PUBLIC PLACE;**

23                   **(3) REQUIRED TO MOVE TO A DESIGNATED AREA WITHIN A**  
24 **DWELLING, STOREHOUSE, OR PUBLIC PLACE; OR**

25                   **(4) REQUIRED TO REMAIN IN A DESIGNATED SAFE AREA WITHIN A**  
26 **DWELLING, STOREHOUSE, OR PUBLIC PLACE.**

27           **(D) (1) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF THE**  
28 **MISDEMEANOR OF MAKING A THREAT OF MASS VIOLENCE AND ON CONVICTION**  
29 **IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 10 YEARS OR A FINE NOT**  
30 **EXCEEDING \$10,000 OR BOTH.**

31                   **(2) IN ADDITION TO THE PENALTIES PROVIDED IN PARAGRAPH**  
32 **(1) OF THIS SUBSECTION, A COURT SHALL ORDER A PERSON CONVICTED UNDER**  
33 **THIS SECTION TO REIMBURSE THE APPROPRIATE UNIT OF FEDERAL, STATE, OR**

1 LOCAL GOVERNMENT OR OTHER PERSON FOR EXPENSES AND LOSSES  
2 INCURRED IN RESPONDING TO THE UNLAWFUL THREAT UNLESS THE COURT  
3 STATES ON THE RECORD THE REASONS WHY REIMBURSEMENT WOULD BE  
4 INAPPROPRIATE.

5 (E) A PERSON WHO VIOLATES THIS SECTION MAY BE INDICTED,  
6 PROSECUTED, TRIED, AND CONVICTED IN ANY COUNTY WHERE:

7 (1) THE THREAT WAS RECEIVED;

8 (2) THE THREAT WAS MADE; OR

9 (3) THE CONSEQUENCES OF THE THREAT OCCURRED.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
11 October 1, 2014.
