# A BILL ENTITLED

1 AN ACT concerning

## Criminal Law – Third Degree Sexual Offense – Burglary

3 FOR the purpose of establishing that engaging in sexual contact with another without 4 the consent of the other in connection with a first, second, or third degree  $\mathbf{5}$ burglary constitutes sexual offense in the third degree; establishing that, to be 6 convicted under a certain provision of law, the defendant also must be convicted 7 of a certain crime; altering the definitions of "tier I sex offender", "tier II sex 8 offender", and "tier III sex offender" applicable to provisions relating to sex 9 offender registration to include certain acts constituting sexual offense in the third degree; providing for the application of this Act; and generally relating to 10 sexual offense in the third degree. 11

1 (b) A person who violates this section is guilty of the felony of sexual offense 2 in the third degree and on conviction is subject to imprisonment not exceeding 10 3 years.

4 (C) TO BE CONVICTED UNDER SUBSECTION (A)(1)(II)5 OF THIS 5 SECTION, THE DEFENDANT MUST ALSO BE CONVICTED OF BURGLARY IN THE 6 FIRST DEGREE UNDER § 6–202 OF THIS ARTICLE, BURGLARY IN THE SECOND 7 DEGREE UNDER § 6–203 OF THIS ARTICLE, OR BURGLARY IN THE THIRD 8 DEGREE UNDER § 6–204 OF THIS ARTICLE.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be 9 construed to apply only prospectively and may not be applied or interpreted to have 10 any effect on or application to any acts committed before the effective date of this Act.

11 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 2014.
