### State Board of Examiners in Optometry – Cease and Desist Orders, **Injunctive Relief, and Penalties**

#### 4 FOR the purpose of authorizing the State Board of Examiners in Optometry to issue a $\mathbf{5}$ cease and desist order or obtain injunctive relief for a violation of certain 6 provisions of law; providing that certain actions may be brought by certain 7 persons in certain counties; providing that proof of certain damages is not required for certain actions; providing that a person who violates certain 8 9 provisions of law is subject to a civil fine not exceeding a certain amount to be assessed by the Board in accordance with certain regulations; requiring the 10 Board to pay certain penalties into the State Board of Examiners in Optometry 11 12Fund; providing for the application of this Act; and generally relating to the State Board of Examiners in Optometry, cease and desist orders, injunctive 13 relief, and penalties. 14

10 Except as otherwise provided in this title, a person may not practice, attempt to 11 practice, or offer to practice optometry in this State unless licensed by the Board.

12 11-502.

13 Unless licensed to practice optometry under this title, a person may not 14 represent to the public by title, by description of services, methods, or procedures, or 15 otherwise, that the person practices optometry.

16 11–504.

17 (a) Knowingly selling or dispensing contact lenses or replacement contact 18 lenses without a valid and unexpired prescription or replacement contact lens 19 prescription shall be considered a violation of this title.

20 (b) The Board shall investigate any alleged violation of this section or § 21 11-404.4 of this title and may, notwithstanding § 11-205 of this title:

- (1) Issue subpoenas, administer oaths, and examine witnesses; and

23 (2) Enforce any provision of this title by injunction or other 24 appropriate proceedings.

(c) An action under this section is in addition to and not instead of criminal
 prosecution under § 11–505 of this subtitle.

28 **(A)** A person who violates any provision of this title is guilty of a 29 misdemeanor and on conviction is subject to a fine not exceeding \$500 or 30 imprisonment not exceeding 6 months or both.

1 (B) (1) THIS SUBSECTION DOES NOT APPLY TO AN INDIVIDUAL 2 LICENSED UNDER TITLE 14, SUBTITLE 3 OF THIS ARTICLE.

3 (2) A PERSON WHO VIOLATES § 11–501, § 11–502, OR § 11–504 OF 4 THIS SUBTITLE IS SUBJECT TO A CIVIL FINE NOT EXCEEDING \$50,000 TO BE 5 ASSESSED BY THE BOARD IN ACCORDANCE WITH REGULATIONS ADOPTED BY 6 THE BOARD.

7 (3) THE BOARD SHALL PAY ANY PENALTY COLLECTED UNDER
8 THIS SUBSECTION INTO THE STATE BOARD OF EXAMINERS IN OPTOMETRY
9 FUND.
