## A BILL ENTITLED

2 Procurement - Debarment - Violations of Law

FOR the purpose of providing that a person may be debarred from entering into a contract with the State if the person, or a certain other person connected to the person, has been convicted of a violation of certain provisions of federal law or State law or, under certain circumstances, has been found to have willfully or knowingly violated certain provisions of State law; and generally relating to debarment from State contracts.

23 24 25 26 27	(c) A person may be debarred from entering into a contract with the State if the person, an officer, partner, controlling stockholder or principal of that person, or any other person substantially involved in that person's contracting activities has been debarred from federal contracts under the Federal Acquisition Regulations, as provided in 48 C.F.R. Chapter 1.
28	(d) A person may be debarred from entering into a contract with the State:
29 30 31	(1) if the Board finds that the person was established or operates in a manner designed to evade the application of this title or to defeat the purpose of this title;

1 for one of the following violations of a contract provision if the (3) 2 Board believes it to be serious enough to justify debarment: 3 the deliberate failure, without good cause, to perform in accordance with the specifications, or within the time limit, provided in a contract; or 4 5 within the preceding 5 years, the failure to perform or of 6 unsatisfactory performance in accordance with the terms of one or more contracts, 7 unless the failure to perform or unsatisfactory performance was caused by acts beyond 8 the control of the person; 9 if the person is a competing contractor, or any officer, employee, **(4)** representative, agent, or consultant of any competing contractor who violates § 13–211 10 of this article; or 11 12 for any other cause that the Board determines to be so serious as to (5)13 affect the integrity of the procurement process.
