A BILL ENTITLED

1 AN ACT concerning

2 **Marijuana Control Act of 2014**

3 FOR the purpose of repealing certain criminal prohibitions against the use and
4 possession of marijuana and marijuana paraphernalia; establishing certain
5 exemptions from prosecution for certain persons for using, obtaining,
6 purchasing, transporting, or possessing marijuana under certain circumstances;
7 providing that certain conduct is lawful; establishing certain exemptions from
8 prosecution for certain retailers, marijuana product manufacturers, marijuana
9 cultivation facilities, and safety compliance facilities in certain circumstances;
10 establishing a certain affirmative defense; prohibiting a certain adult from
11 cultivating marijuana under certain circumstances; requiring the Comptroller
12 or the Comptroller's designee to establish certain procedures; providing that
13 this Act does not exempt certain conduct from certain penalties; prohibiting a
14 person from smoking marijuana in a public place; providing that employers are
15 not required to accommodate certain conduct; authorizing landlords and
16 innkeepers to prohibit certain behavior in certain locations; prohibiting a person
17 from falsely representing the person's age for certain purposes; providing that
18 this Act, by operation of law, expunges certain convictions; providing that this
19 Act does not repeal or modify certain other statutes; establishing a procedure
20 for a certain retailer, marijuana cultivation facility, or safety compliance facility
21 to register under this Act; authorizing local governments to enact certain
22 ordinances or regulations not in conflict with this Act; prohibiting a retailer,
23 marijuana cultivation facility, or other person from advertising in a certain
24 manner; requiring a retailer to include a certain safety insert with the sale of
25 marijuana; requiring a marijuana cultivation facility to create certain
26 packaging; providing for the cultivation of marijuana in certain circumstances;
27 requiring a certain marijuana cultivation facility to have certain documentation

1 at certain times; prohibiting a retailer from selling, giving, or otherwise
2 furnishing marijuana to a person under a certain age; prohibiting a retailer
3 from allowing a person under a certain age to be present in a certain location
4 under certain circumstances; prohibiting a retailer from selling, giving, or
5 otherwise furnishing more than a certain amount of marijuana to a person in a
6 single transaction, knowingly and willfully selling, giving, or otherwise
7 furnishing an amount of marijuana to a person under certain circumstances,
8 purchasing marijuana from a person other than a marijuana cultivation facility,
9 or violating certain regulations; providing a certain defense; prohibiting a
10 marijuana cultivation facility from allowing a person under a certain age to be
11 present on certain premises under certain circumstances, selling, giving, or
12 otherwise furnishing marijuana to certain persons, purchasing marijuana from
13 certain persons, or purchasing or selling, giving, or otherwise furnishing
14 marijuana in a certain manner; authorizing the Comptroller to suspend or
15 terminate a certain registration under certain circumstances; authorizing a
16 certain court action under certain circumstances; providing that it is not a
17 violation of State or local law for a person to purchase and possess a material or
18 product made, in whole or in part, with industrial hemp; requiring the
19 Department of Agriculture to adopt certain rules and regulations; providing
20 that a certain person is authorized to manufacture, produce, use, obtain,
21 purchase, transport, or possess marijuana paraphernalia in a certain manner or
22 to distribute or sell marijuana paraphernalia to certain persons; prohibiting a
23 person under a certain age from possessing marijuana; requiring the Governor
24 to appoint a certain oversight committee; requiring the oversight committee to
25 undertake certain duties; imposing a certain excise tax on marijuana cultivation
26 facilities; requiring the Comptroller to allocate certain tax funds in a certain
27 manner; requiring the Comptroller to administer and carry out this Act and to
28 adopt certain regulations; allowing a certain deduction from State taxes;
29 providing certain penalties for a violation of this Act; defining certain terms;
30 and generally relating to marijuana.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 11 MARYLAND, That the Laws of Maryland read as follows:

12 **Article – Criminal Law**

13 5–601.

14 (c) (2) [(i)] A person whose violation of this section involves the use or
 15 possession of marijuana is subject to [imprisonment not exceeding 1 year or a fine not
 16 exceeding \$1,000 or both.

17 (ii) 1. A person convicted of the use or possession of less
 18 than 10 grams of marijuana is subject to imprisonment not exceeding 90 days or a fine
 19 not exceeding \$500 or both.

20 2. Unless specifically charged by the State, the use or
 21 possession of less than 10 grams of marijuana under subparagraph 1 of this
 22 subparagraph may not be considered a lesser included crime of any other crime.

23 3. If a person is convicted under this subparagraph, the
 24 court shall stay any sentence imposed that includes an unserved, nonsuspended period
 25 of imprisonment without requiring an appeal bond:

26 A. until the time for filing an appeal has expired; and

27 B. if an appeal is filed, during the pendency of the
 28 appeal] **THE PROVISIONS OF SUBTITLE 12 OF THIS TITLE.**

30 (d) (2) A person who violates this section involving the use or possession
 31 of marijuana is subject to [imprisonment not exceeding 1 year or a fine not exceeding
 32 \$1,000 or both] **THE PROVISIONS OF SUBTITLE 12 OF THIS TITLE.**

2 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
3 INDICATED.

4 (B) "COMPTROLLER" MEANS THE COMPTROLLER OF MARYLAND OR
5 THE COMPTROLLER'S DESIGNEE.

6 (C) "ENCLOSED LOCKED FACILITY" INCLUDES A BUILDING, ROOM,
7 GREENHOUSE, FULLY ENCLOSED FENCED-IN AREA, OR OTHER LOCATION
8 ENCLOSED ON ALL SIDES AND EQUIPPED WITH LOCKS OR OTHER SECURITY
9 DEVICES THAT PERMIT ACCESS ONLY BY:

10 (1) AN EMPLOYEE, AGENT, OR OWNER OF A MARIJUANA
11 CULTIVATION FACILITY, PROVIDED THAT THE EMPLOYEE, AGENT, OR OWNER IS
12 AT LEAST 21 YEARS OLD;

13 (2) A GOVERNMENT EMPLOYEE PERFORMING AN OFFICIAL DUTY
14 OF THE EMPLOYEE;

15 (3) A CONTRACTOR PERFORMING LABOR THAT DOES NOT
16 INCLUDE MARIJUANA CULTIVATION, PACKAGING, OR PROCESSING IF THE
17 CONTRACTOR IS ACCOMPANIED BY AN EMPLOYEE, AGENT, OR OWNER OF THE
18 MARIJUANA CULTIVATION FACILITY WHEN THE CONTRACTOR IS IN AREAS IN
19 WHICH MARIJUANA IS BEING GROWN OR STORED; OR

20 (4) A MEMBER OF THE MEDIA, AN ELECTED OFFICIAL, OR
21 ANOTHER INDIVIDUAL WHO IS TOURING THE MARIJUANA CULTIVATION
22 FACILITY IF THE INDIVIDUAL IS ACCOMPANIED BY AN EMPLOYEE, AGENT, OR
23 OWNER OF THE FACILITY AND IS AT LEAST 21 YEARS OLD.

24 (D) "INDUSTRIAL HEMP" MEANS ANY LOW-TETRAHYDROCANNABINOL
25 OIL-SEED AND FIBER VARIETY OF CANNABIS SATIVA L. WITH A
26 DELTA-9-TETRAHYDROCANNABINOL CONCENTRATION THAT DOES NOT EXCEED
27 0.3% ON A DRY WEIGHT BASIS.

28 (E) (1) "MARIJUANA" MEANS:

29 (I) ALL PARTS OF THE GENUS CANNABIS, WHETHER
30 GROWING OR NOT;

31 (II) THE SEEDS OF THE PLANT;

1 (III) THE RESIN EXTRACTED FROM A PART OF THE PLANT; OR

2 (IV) EVERY COMPOUND, MANUFACTURE, SALT, DERIVATIVE,
3 MIXTURE, OR PREPARATION OF THE PLANT, ITS SEEDS, OR ITS RESIN.

4 (2) "MARIJUANA" DOES NOT INCLUDE THE MATURE STALKS OF
5 THE PLANT, FIBER PRODUCED FROM THE STALKS, OIL OR CAKE MADE FROM
6 THE SEEDS OF THE PLANT, ANY OTHER COMPOUND, MANUFACTURE, SALT,
7 DERIVATIVE, MIXTURE, OR PREPARATION OF THE MATURE STALKS, EXCEPT THE
8 EXTRACTED RESIN, FIBER, OIL OR CAKE, OR THE STERILIZED SEED OF THE
9 PLANT THAT IS INCAPABLE OF GERMINATION.

10 (F) "MARIJUANA CULTIVATION FACILITY" MEANS AN ENTITY THAT IS:

11 (1) REGISTERED IN ACCORDANCE WITH THIS SUBTITLE TO BE
12 EXEMPT FROM STATE PENALTIES FOR CULTIVATING, PREPARING, PACKAGING,
13 TRANSPORTING, OR SELLING MARIJUANA TO A MARIJUANA PRODUCT
14 MANUFACTURER, RETAILER, OR ANOTHER MARIJUANA CULTIVATION FACILITY;
15 OR

16 (2) EXEMPT FROM STATE PENALTIES UNDER § 5-1212 OF THIS
17 SUBTITLE DUE TO FAILURE OF THE COMPTROLLER TO ISSUE REGISTRATIONS.

18 (G) "MARIJUANA ESTABLISHMENT" MEANS A RETAILER, MARIJUANA
19 CULTIVATION FACILITY, MARIJUANA PRODUCT MANUFACTURER, OR SAFETY
20 COMPLIANCE FACILITY.

21 (H) "MARIJUANA PARAPHERNALIA" MEANS EQUIPMENT, PRODUCTS, OR
22 MATERIALS THAT ARE USED OR INTENDED FOR USE IN:

23 (1) PLANTING, PROPAGATING, CULTIVATING, GROWING,
24 HARVESTING, MANUFACTURING, COMPOUNDING, CONVERTING, PRODUCING,
25 PROCESSING, PREPARING, TESTING, ANALYZING, PACKAGING, REPACKAGING,
26 STORING, CONTAINING, OR CONCEALING MARIJUANA; OR

27 (2) INGESTING OR INHALING MARIJUANA OR OTHERWISE
28 INTRODUCING MARIJUANA INTO THE HUMAN BODY.

29 (I) "MARIJUANA PRODUCT" MEANS A GOOD COMPOSED OF MARIJUANA
30 AND OTHER INGREDIENTS THAT IS INTENDED FOR USE OR CONSUMPTION.

1 **(J) “MARIJUANA PRODUCT MANUFACTURER” MEANS AN ENTITY THAT**
2 **IS:**

3 **(1) REGISTERED IN ACCORDANCE WITH THIS SUBTITLE TO BE**
4 **EXEMPT FROM STATE PENALTIES FOR:**

5 **(I) PURCHASING MARIJUANA FROM MARIJUANA**
6 **CULTIVATION FACILITIES;**

7 **(II) MANUFACTURING, PREPARING, AND PACKAGING**
8 **MARIJUANA PRODUCTS; AND**

9 **(III) SELLING MARIJUANA PRODUCTS TO RETAILERS OR**
10 **ANOTHER MARIJUANA PRODUCT MANUFACTURER; OR**

11 **(2) EXEMPT FROM STATE PENALTIES UNDER § 5-1213 OF THIS**
12 **SUBTITLE DUE TO FAILURE OF THE COMPTROLLER TO ISSUE REGISTRATIONS.**

13 **(K) “PERSONAL USE AMOUNT OF USABLE MARIJUANA” MEANS:**

14 **(1) 1 OUNCE OR LESS OF MARIJUANA;**

15 **(2) 5 GRAMS OR LESS OF HASHISH;**

16 **(3) 16 OUNCES OF MARIJUANA PRODUCTS OTHER THAN HASHISH**
17 **IN SOLID FORM; OR**

18 **(4) 72 OUNCES OF MARIJUANA IN LIQUID FORM.**

19 **(L) (1) “PUBLIC PLACE” MEANS A STREET, AN ALLEY, A PARK, A**
20 **SIDEWALK, A PLACE OR BUILDING OF BUSINESS OR ASSEMBLY OPEN TO OR**
21 **FREQUENTED BY THE PUBLIC, OR ANY OTHER PLACE TO WHICH THE PUBLIC**
22 **HAS ACCESS.**

23 **(2) “PUBLIC PLACE” DOES NOT INCLUDE AN INDIVIDUAL**
24 **DWELLING.**

25 **(M) “RETAILER” MEANS AN ENTITY THAT IS:**

26 **(1) REGISTERED IN ACCORDANCE WITH THIS SUBTITLE TO BE**
27 **EXEMPT FROM STATE PENALTIES FOR PURCHASING MARIJUANA FROM A**
28 **MARIJUANA CULTIVATION FACILITY OR MARIJUANA PRODUCT MANUFACTURER**

1 AND SELLING MARIJUANA AND MARIJUANA PARAPHERNALIA TO CUSTOMERS
2 WHO ARE AT LEAST 21 YEARS OLD; OR

3 (2) EXEMPT FROM STATE PENALTIES UNDER § 5-1211 OF THIS
4 SUBTITLE DUE TO THE COMPTROLLER NOT ISSUING REGISTRATIONS.

5 (N) "SAFETY COMPLIANCE FACILITY" MEANS AN ENTITY THAT IS:

6 (1) REGISTERED IN ACCORDANCE WITH THIS SUBTITLE TO BE
7 EXEMPT FROM STATE PENALTIES FOR TESTING MARIJUANA, INCLUDING
8 MARIJUANA PRODUCTS, FOR POTENCY AND CONTAMINANTS; OR

9 (2) EXEMPT FROM STATE PENALTIES UNDER § 5-1214 OF THIS
10 SUBTITLE DUE TO THE COMPTROLLER NOT ISSUING REGISTRATIONS.

11 (O) (1) "SMOKING" MEANS HEATING TO AT LEAST THE POINT OF
12 COMBUSTION, CAUSING PLANT MATERIAL TO BURN.

13 (2) "SMOKING" DOES NOT INCLUDE VAPORIZING.

14 (P) "STATE PROSECUTION" MEANS CRIMINAL PROSECUTION INITIATED
15 OR MAINTAINED BY THE STATE OR AN AGENCY OR A POLITICAL SUBDIVISION OF
16 THE STATE.

23 FOR THE FOLLOWING ACTS:

26 USABLE MARIJUANA;

27 (2) CONTROLLING THE PREMISES OR A VEHICLE WHERE
28 AMOUNTS OF MARIJUANA THAT ARE LAWFUL UNDER THIS SUBTITLE ARE
29 POSSESSED, PROCESSED, OR STORED BY PERSONS WHO ARE AT LEAST 21 YEARS
30 OLD, PROVIDED THAT THE TOTAL NUMBER OF PLANTS MAY NOT EXCEED 18 IN
31 AN INDIVIDUAL RESIDENCE;

1 **(3) USING, OBTAINING, MANUFACTURING, PRODUCING,**
2 **PURCHASING, TRANSPORTING, OR POSSESSING, ACTUALLY OR**
3 **CONSTRUCTIVELY, MARIJUANA PARAPHERNALIA;**

4 **(4) SELLING MARIJUANA SEEDS OR MARIJUANA PARAPHERNALIA**
5 **TO A MARIJUANA ESTABLISHMENT OR TO PERSONS WHO ARE AT LEAST 21**
6 **YEARS OLD;**

7 **(5) TRANSFERRING A PERSONAL USE AMOUNT OF USABLE**
8 **MARIJUANA AND THREE OR FEWER MARIJUANA SEEDLINGS OR CUTTINGS**
9 **WITHOUT REMUNERATION TO A PERSON WHO IS AT LEAST 21 YEARS OLD;**

10 **(6) TRANSFERRING AN AMOUNT OF MARIJUANA OR MARIJUANA**
11 **PRODUCTS THAT A PERSON IS ALLOWED TO POSSESS UNDER THIS SECTION TO A**
12 **SAFETY COMPLIANCE FACILITY;**

13 **(7) AIDING AND ABETTING ANOTHER PERSON WHO IS AT LEAST 21**
14 **YEARS OLD IN ACTIONS THAT ARE ALLOWED UNDER THIS SUBTITLE;**

15 **(8) CULTIVATING SIX OR FEWER MARIJUANA PLANTS, NO MORE**
16 **THAN THREE OF WHICH MAY BE MATURE, FLOWERING PLANTS, AND**
17 **POSSESSING THE MARIJUANA PRODUCED BY THE PLANTS ON THE PREMISES**
18 **WHERE THE PLANTS WERE GROWN; OR**

19 **(9) ASSISTING WITH THE CULTIVATION OF MARIJUANA PLANTS**
20 **THAT ARE CULTIVATED AT THE SAME LOCATION BY ADULTS AT LEAST 21 YEARS**
21 **OLD, WITH THE TOTAL NUMBER OF MATURE, FLOWERING PLANTS NOT**
22 **EXCEEDING 18 IN A DWELLING UNIT.**

23 **(B) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, A RETAILER**
24 **OR ANY OTHER PERSON THAT IS AT LEAST 21 YEARS OLD AND ACTING IN A**
25 **CAPACITY AS AN OWNER, A PRINCIPAL OFFICER, A PARTNER, A BOARD MEMBER,**
26 **AN EMPLOYEE, OR AN AGENT OF A RETAILER IS EXEMPT FROM ARREST, CIVIL**
27 **OR CRIMINAL PENALTY, SEIZURE OR FORFEITURE OF ASSETS, DISCIPLINE BY A**
28 **STATE OR LOCAL LICENSING BOARD, OR STATE PROSECUTION FOR THE**
29 **FOLLOWING ACTS:**

3 **MARIJUANA PRODUCT MANUFACTURER OR A RETAILER;**

4 **(3) OBTAINING OR PURCHASING MARIJUANA FROM A MARIJUANA**
5 **CULTIVATION FACILITY OR A RETAILER;**

6 **(4) OBTAINING OR PURCHASING MARIJUANA FROM A MARIJUANA**
7 **PRODUCT MANUFACTURER OR A RETAILER;**

8 **(5) MANUFACTURING, POSSESSING, PRODUCING, OBTAINING, OR**
9 **PURCHASING MARIJUANA PARAPHERNALIA;**

10 **(6) SELLING, TRANSFERRING, OR DELIVERING MARIJUANA,**
11 **SEEDLINGS AND CUTTINGS OF MARIJUANA PLANTS, MARIJUANA PRODUCTS, OR**
12 **MARIJUANA PARAPHERNALIA TO A PERSON WHO IS AT LEAST 21 YEARS OLD OR**
13 **TO ANOTHER MARIJUANA RETAILER;**

14 **(7) TRANSFERRING OR DELIVERING MARIJUANA TO A SAFETY**
15 **COMPLIANCE FACILITY; OR**

16 **(8) CONTROLLING THE PREMISES OR A VEHICLE WHERE**
17 **MARIJUANA, MARIJUANA PRODUCTS, OR MARIJUANA PARAPHERNALIA IS**
18 **POSSESSED, SOLD, OR DEPOSITED.**

19 **(C) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, A MARIJUANA**
20 **CULTIVATION FACILITY OR OTHER PERSON WHO IS AT LEAST 21 YEARS OLD AND**
21 **ACTING IN A CAPACITY AS AN OWNER, A PRINCIPAL OFFICER, A PARTNER, A**
22 **BOARD MEMBER, AN EMPLOYEE, OR AN AGENT OF A MARIJUANA CULTIVATION**
23 **FACILITY IS EXEMPT FROM ARREST, CIVIL OR CRIMINAL PENALTY, SEIZURE OR**
24 **FORFEITURE OF ASSETS, DISCIPLINE BY A STATE OR LOCAL LICENSING BOARD,**
25 **OR STATE PROSECUTION FOR THE FOLLOWING ACTS:**

26 **(1) CULTIVATING, PACKING, POSSESSING, PROCESSING,**

31 **RETAILER, MARIJUANA PRODUCT MANUFACTURER, OR A MARIJUANA**

11 **PRODUCT MANUFACTURER OR OTHER PERSON WHO IS AT LEAST 21 YEARS OLD**
12 **AND ACTING IN A CAPACITY AS AN OWNER, A PRINCIPAL OFFICER, A PARTNER, A**
