2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That the Laws of Maryland read as follows:

6 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE
7 MEANINGS INDICATED.

8 (2) “VIDEO LOTTERY FACILITY” HAS THE MEANING STATED IN §
9 9-1A-01 OF THE STATE GOVERNMENT ARTICLE.

10 (3) “VIDEO LOTTERY OPERATION LICENSEE” HAS THE MEANING
11 STATED IN § 9-1A-01 OF THE STATE GOVERNMENT ARTICLE.

12 [(a)] (B) The Administration may certify to the State Lottery and Gaming
13 Control Agency the name of any obligor who is in arrears in the amount of \$150 or
14 more if:

15 (1) the Administration has accepted an assignment of support under §
16 5-312(b)(2) of the Human Services Article; or

17 (2) the recipient of support payments has filed an application for
18 support enforcement services with the Administration.

19 [(b)] (C) The certification shall contain:

20 (1) the full name of the obligor, and any other names known to be used
21 by the obligor;

22 (2) the Social Security number of the obligor; and

23 (3) the amount of the arrearage.

24 [(c)] (D) If an obligor who has been certified as an obligor wins a lottery
25 prize to be paid by check directly by the State Lottery and Gaming Control Agency, the
26 State Lottery and Gaming Control Agency shall send a notice to the obligor that:

27 (1) the obligor has won a prize to be paid by check directly by the State
28 Lottery and Gaming Control Agency;

29 (2) the State Lottery and Gaming Control Agency has received
30 certification from the Child Support Enforcement Administration of the obligor’s child
31 support arrearage in the amount specified;

1 (3) subsection [(d)] (F) of this section requires the State Lottery and
2 Gaming Control Agency to withhold the prize to pay it towards the obligor's support
3 arrears;

4 (4) the State Lottery and Gaming Control Agency proposes to transfer
5 the prize, or that part of it which is equal to the support arrears, to the
6 Administration if no appeal is filed within 15 days;

7 (5) the obligor may appeal to the Administration if the obligor disputes
8 the existence or the amount of the arrears;

9 (6) if the obligor appeals to the Administration, the prize will be
10 distributed as the Administration directs; and

11 (7) if no appeal is filed within 15 days, the prize, or that part of it equal
12 to the support arrears, will be transferred to the Administration.

13 **(E) IF AN OBLIGOR WHO OWES CHILD SUPPORT AND HAS BEEN**
14 **CERTIFIED AS AN OBLIGOR WINS A PRIZE AT A VIDEO LOTTERY FACILITY**
15 **REQUIRING THE ISSUANCE OF INTERNAL REVENUE SERVICE FORM W-2G OR A**
16 **SUBSTANTIALLY EQUIVALENT FORM BY A VIDEO LOTTERY OPERATION**
17 **LICENSEE, THE VIDEO LOTTERY OPERATION LICENSEE SHALL PROVIDE A**
18 **NOTICE TO THE OBLIGOR THAT:**

19 **(1) THE OBLIGOR HAS WON A PRIZE TO BE PAID BY CASH OR**
20 **CHECK DIRECTLY BY THE VIDEO LOTTERY OPERATION LICENSEE;**

21 **(2) THE STATE LOTTERY AND GAMING CONTROL AGENCY HAS**
22 **RECEIVED CERTIFICATION FROM THE CHILD SUPPORT ENFORCEMENT**
23 **ADMINISTRATION OF THE OBLIGOR'S CHILD SUPPORT ARREARS IN THE**
24 **AMOUNT SPECIFIED;**

25 **(3) SUBSECTION (F) OF THIS SECTION REQUIRES THE VIDEO**
26 **LOTTERY OPERATION LICENSEE TO WITHHOLD THE PRIZE TO PAY IT TOWARDS**
27 **THE OBLIGOR'S CHILD SUPPORT ARREARS;**

28 **(4) THE VIDEO LOTTERY OPERATION LICENSEE PROPOSES TO**
29 **TRANSFER THE PRIZE, OR THAT PART OF IT WHICH IS EQUAL TO THE CHILD**
30 **SUPPORT ARREARS, TO THE ADMINISTRATION IF NO APPEAL IS FILED WITHIN**
31 **15 DAYS;**

32 **(5) THE OBLIGOR MAY APPEAL TO THE ADMINISTRATION IF THE**
33 **OBLIGOR DISPUTES THE EXISTENCE OR THE AMOUNT OF THE CHILD SUPPORT**
34 **ARREARS;**

1 **(6) IF THE OBLIGOR APPEALS TO THE ADMINISTRATION, THE**
2 **PRIZE WILL BE DISTRIBUTED AS THE ADMINISTRATION DIRECTS; AND**

3 **(7) IF NO APPEAL IS FILED WITHIN 15 DAYS, THE PRIZE, OR THAT**
4 **PART OF IT EQUAL TO THE CHILD SUPPORT ARREARAGE, WILL BE TRANSFERRED**
5 **TO THE ADMINISTRATION.**

6 **[(d)] (F) If the prize exceeds the arrearage, the State Lottery and Gaming**
7 **Control Agency OR VIDEO LOTTERY OPERATION LICENSEE shall immediately pay**
8 **the excess to the obligor. The State Lottery and Gaming Control Agency OR VIDEO**
9 **LOTTERY OPERATION LICENSEE shall withhold any part of the prize that does not**
10 **exceed the arrearage until notified by the Administration to whom the withheld prize**
11 **money shall be paid.**

12 **[(e)] (G) Upon receipt of a notice from the State Lottery and Gaming Control**
13 **Agency OR VIDEO LOTTERY OPERATION LICENSEE any obligor who disputes the**
14 **existence or amount of the arrearage may appeal the proposed transfer within 15 days**
15 **of the date of the notice to the Administration.**

16 **[(f)] (H) If no appeal is filed within 15 days, the State Lottery and Gaming**
17 **Control Agency OR VIDEO LOTTERY OPERATION LICENSEE shall transfer the**
18 **amount of the prize withheld to the Administration.**

19 **[(g)] (I) The Administration shall notify the State Lottery and Gaming**
20 **Control Agency OR VIDEO LOTTERY OPERATION LICENSEE that upon appeal, the**
21 **withheld prize shall be:**

22 **(1) paid to the obligor;**

23 **(2) transferred to the Administration; or**

24 **(3) partly paid to the obligor and partly transferred to the**
25 **Administration, in the amounts specified.**
