1 AN ACT concerning

Public Service Commission - Competitive Retail Electricity and Gas Supply Consumer Protection - Report

4 FOR the purpose of requiring the Public Service Commission to submit a certain report to the General Assembly on or before a certain date on the status of the $\mathbf{5}$ 6 Commission's efforts to provide appropriate protections for consumers in 7 connection with competitive retail electricity supply and retail gas supply and recommendations regarding ratepayer protections; specifying the contents of 8 9 the report; requiring the Commission to convene a certain workgroup for a 10 certain purpose; providing for the termination of this Act; and generally relating 11 to consumer protection in connection with competitive retail electricity and gas 12 supply.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That:

15 (a) On or before January 1, 2015, the Public Service Commission shall 16 submit a report to the General Assembly, in accordance with § 2–1246 of the State 17 Government Article, on the status of the Commission's efforts to provide appropriate 18 protections for consumers in connection with competitive retail gas supply and 19 competitive retail electricity supply, and recommendations as to how to better protect 20 ratepayers.

(b) The report shall include information and recommendations concerning:

19 20	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2014. It shall remain effective for a period of 1 year and 2 months and, at the

end of July 31, 2015, with no further action required by the General Assembly, this

Act shall be abrogated and of no further force and effect.
